Mr Thomas has requested that as he intends to operate this vehicle for Executive and Airport Hire only, that he be granted an exemption from Condition 5a and 5b of the Council's Licence Conditions, namely that they be not required to display door stickers and a licence plate on the rear bumper of his Vehicle.

Should the Licensing Committee agree to grant Mr Thomas an exemption from condition 5a and 5b of the Council's Licence Conditions for Private Hire vehicles, then the following Licence Conditions be attached to the Licence:-

That the licensed Mercedes Vito registration WV65 UTH be exempt from licence conditions 5a and 5b, whilst being used for Executive and Airport hire purposes as outlined in the application by Mr Thomas.

That should the vehicle be used for Private Hire other than executive hire, then the applicant shall immediately notify the Licensing Authority and the exemption shall cease in relation to such hiring.

That the vehicle displays an identification disc on the front and rear windscreens, as specified by the Licensing Authority.

3. MRS LINDA VICTORIA MORGAN - APPLICATION TO RENEW A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mrs. Morgan had contacted officers to advise that she was unable to attend today's meeting.

UNANIMOUSLY RESOLVED that consideration of the application from Mrs. Linda Victoria Morgan to renew her Hackney Carriage/Private Hire Dual Driver's Licence be deferred to the next meeting of the Committee.

4. PRIVATE HIRE VEHICLE LICENCE

The Committee considered an application from Mr David Mark Jones-Dunstall of

South Wales Travel, Bwythyn y Coed, 1 Dol y Dderwen, Bonllwyn, Ammanford, Carmarthenshire, to be granted an exemption from Conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles for his Renault Grand Scenic registration number SP11 NJZ.

Mr Jones-Dunstall had requested that as he intended to operate the vehicle for Executive and Business hire only, he be granted an exemption from Conditions 5a and 5b of the Council's Licence Conditions, namely that he be not required to display door stickers and a licence plate on the rear bumper of his vehicle.

The Public Health Services Manager advised that should the Licensing Committee agree to grant an exemption from conditions 5a and 5b of the Council's Licence Conditions for Private Hire vehicles, then the following licence conditions would be attached to the licence:-

[i] That the licensed Renault Grand Scenic registration SP11 NJZ be exempt from licence conditions 5a and 5b, whilst being used for executive and business hire purposes as outlined in the application by Mr Jones-Dunstall;

[ii] That should the vehicle be used for Private Hire other than executive and business hire, then the applicant shall immediately notify the Licensing Authority and the exemption shall cease in relation to such hiring;

[iii] That the vehicle displays an identification disc on the front and rear windscreens, as specified by the Licensing Authority.

UNANIMOUSLY RESOLVED that the application submitted by Mr David Mark Jones-Dunstall for an exemption for his Renault Grand Scenic registration number SP11 NJZ from Conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles be granted in accordance with the conditions detailed within the report.

5. MRS SARAH JENNA WYNNE - APPLICATION TO RENEW A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mrs. Wynne had contacted officers to advise that she was unable to attend today's meeting but was happy for her application to be determined in her absence. The Public Health Services Manager advised that there was an issue concerning Mrs. Wynne's application.

The Committee was informed that Mr Christopher Graham Richards of 7 Dolau Fan Road, Burry Port, was a licensed hackney carriage/private hire dual driver with the authority and the Committee interviewed Mr Richards with regard to an issue which had arisen in relation to his licence.

The Committee considered an application from Mr Philip Mark Jones of 23 Belvedere Avenue, Carmarthen, for the grant of a hackney carriage/private hire dual drivers licence.

The Committee interviewed Mr Jones with regard to his application.

The statutory policies had to be reviewed periodically to ensure that they were up to date and reflected feedback from the local community that the statutory objectives were being met. As part of the reviews the Council was required to undertake a consultation exercise and details of the consultations had been sent to a number of interested parties, including licence holders, businesses, local residents and their representatives. Both consultations concluded on the 13th of September 2015. Members of the Licensing Committee who had not already submitted a response to the consultations were encouraged to complete the consultation documents in order that they could be submitted and form part of the policy reviews.
