**The applicant wishes to screen “Helfa’r Heli” at the centre. The screening will be authorised under a temporary event notice submitted by the applicant under Section 100 of the Licensing Act 2003.**

**In order to satisfy the requirements of the Licensing Act 2003, the film shown must have a recommendation concerning the admission of children issued by either the film classification body (BBFC) or relevant licensing authority, which in this case is ourselves.**

**This film has previously been considered by committee and given an age classification of 12A in relation to a screening at a different premises.**

**The committee is asked to refer to the guidelines in relation to age ratings produced by the British Board of Film Classification (BBFC).**
