**APPLICATION FOR DISPENSATION BY COUNCILLOR
CHRISTOPHER MARK DAVIES**

An application has been received from Community Councillor C M Davies of St Clears Town Council for dispensation to speak only in respect of Council business relating to or likely to affect St Clears Town Trust.

The Town Trust is a charitable organisation first established in 1889.

Councillor Davies would have a personal interest in any council business relating to or likely to affect this organisation by virtue of paragraph 10(2)(a)(ix)(ee) of the members code of conduct as he is a member of the Trust

This personal interest would also be prejudicial as a member of the public with knowledge of the relevant facts would reasonably regard the interest as so significant that it would be likely to prejudice the Councillor's judgement of the public interest.

Councillor Davies has not specified in his application the grounds set out in the Standards Committees (Grant of Dispensations)(Wales) regulations 2011 (as amended) upon which he relies. However 2 grounds would appear to be relevant, namely;

1. That the nature of the member's interest is such that the member's participation in the business to which the interest relates would not damage public confidence in the conduct of the relevant authority's business.
2. That his participation would be justified by his particular role or expertise

If the committee is minded to grant Councillor Davies a dispensation in respect of this interest it has absolute discretion as to the duration of that dispensation.

An application has been received from Community Councillor W E V J Davies of St Clears Town Council for dispensation to speak only in respect of Council business relating to or likely to affect St Clears Town Trust.

The Town Trust is a charitable organisation first established in 1889

Councillor Davies would have a personal interest in any council business relating to or likely to affect this organisation by virtue of paragraph 10(2)(a)(ix)(ee) of the members code of conduct as he is a member of the Trust

This personal interest would also be prejudicial as a member of the public with knowledge of the relevant facts would reasonably regard the interest as so significant that it would be likely to prejudice the Councillor's judgement of the public interest.

Councillor Davies has submitted his application on the basis of three grounds set out in the Standards Committees (Grant of Dispensations)(Wales) regulations 2011 (as amended) namely;


