

1. DECLARATIONS OF PERSONAL INTEREST.

There were no declarations of personal interest.

2. TO SIGN AS A CORRECT RECORD THE DECISION RECORD OF THE MEETING HELD ON THE 22ND JULY, 2016.

RESOLVED that the decision record of the meeting held on the 22nd July, 2916 be signed as a correct record.

3. WELLNESS AND LIFE SCIENCES ENTERPRISE ZONE ON DEVELOPMENT LAND AT DELTA LAKES, LLANELLI - EXEMPTION AND WAIVER.

The Executive Board member considered a report seeking an exemption to Condition 5.3 of the Council's Contract Procedure Rules in relation to the appointment of Arup, Cardiff Office to produce a revised master plan for South Llanelli, building upon the previous work undertaken by that company for the Llanelli Joint Venture.

The Executive Board Member noted that the report referred to the Memorandum of Understanding between the Council, Hywel Dda University Health Board, Abertawe Bro Morgannwg University Health Board and Swansea University to deliver a "transformational, innovative wellness and life sciences enterprise zone on land at Delta Lakes, Llanelli". The Welsh Government had previously directly funded an initial scoping study on the above proposal and had appointed Arup to undertake the study, on account of its historic master planning of south Llanelli. With works having concluded on that scoping study, a more detailed master plan was now required to provide further detail, to be completed within a 12 month period from May 2016. It was recommended that appointing Arup to undertake the revised master plan would be the most cost-effective option given the limited time scale, its past experiences in the south Llanelli area and that any other consultant would not be able to commence works from the same advanced position thus having to re-evaluate works previously commissioned, generating unnecessary fees and the duplication of works.

The Council's monitoring Officer and Section 151 Officer had both consented to the exemption.

RESOLVED that Condition 5.3 of the Council's Contract Procedure Rules/Quotation Procedure Rules be waived and that Arup, Cardiff Office, be

EXECUTIVE SUMMARY EBM RESOURCES 22ND SEPTEMBER 2016

Opt Out of National Procurement Service Food Contracts

The Authority accepted Welsh Government's invitation to join NPS in December 2012. In agreeing to join NPS, the Executive Board agreed that any future decision not to participate in an individual NPS Contract should be subject to an Executive Board Member for Resources decision.

NPS have signalled for some time their intention to run a collaborative food tender but there has been a series of delays which have resulted in the Authority extending existing arrangements (to 31st March 2017). It is critical that the new arrangements for procuring food are running from 1st April 2017.

The Authority has had significant concerns about NPS' delays in running contract exercises, the lack of savings resulting from NPS Contracts and the potential threat to the local economy.

Following discussion with the Executive Board Member for Resources, the Director of Corporate Services wrote to the Director of NPS on 11th August 2016 setting out the concerns of the Authority:

"I am writing to advise you that having given serious consideration to the existing proposals for the forthcoming NPS Contracts in relation to Food, Carmarthenshire County Council intend to "opt out" of the current NPS Food Contracts.

Our Elected Members have been concerned for some time at the limited benefits of participating in NPS Contracts and we have recently requested details of the financial benefits relating to Carmarthenshire CC's involvement in relation to 2015/16.

As you will appreciate Food is a key commodity for us as a County. We require Value for Money (with quality / food safety being a key issue) and a sensitivity to the local economy. Recent developments in relation to the Stationery Contract concerned us in that partners on the Delivery Group were keen to go for a single contract to cover Wales when there are clearly regional or local companies able to compete in their areas but unable to compete across Wales. This underlines the problem of NPS attempting to represent the whole Welsh Public Sector but not being sensitive to the local economy or local supply issues.



With Food, we have extended our existing contracts twice and have been concerned that NPS may again fail to meet their latest targets. More specifically, I would add the following comments in relation to the existing food commodities:

Bread, Rolls, Cakes and Associated Products

We note that the other contract relating to Bread, Rolls, Cakes and Associated Products is split into 15 geographical zones. Again, we fail to understand the rationale for how the lotting has been put together especially as we were to be part of a bigger geographical area for these products ie Carmarthenshire, Pembrokeshire and Ceredigion. How has it been decided to nearly triple the number of geographical zones across Wales compared to *Groceries, Provisions and Frozen Foods* (4 zones) yet for South West Wales you proposed to increase the size of our geographical zone by adding Ceredigion?

Our County is currently well served by 3 SME's who provide fresh bread to the various establishments across our County. We have historically found it difficult to find Bread Suppliers willing to service all our establishments.

We are at a loss to understand how you could possibly achieve your aim of awarding a Fresh Bread Contract to a single Supplier to cover Carmarthenshire, Pembrokeshire and Ceredigion. Our overall concern is that there is a lack of any understanding in relation to the needs of our Council and the local economy.

Fruit and Vegetables

It is too early for us to comment in detail on this area but it is our intention to critically examine NPS' proposals and reserve the right to "opt out" if we feel that the arrangements are not appropriate or fail to reflect the issues of sustaining and developing the local economy."

1. Legal

EBM Resources has delegated authority to decide to opt out of an NPS arrangement. This is the first time that CCC has opted out of an arrangement. If the Authority does not opt out, there are serious concerns that the Authority will not be able to comply with its legal responsibilities under EU Procurement Rules.

2. Finance

Opting out of the NPS Food Contracts allows the Authority more control over the procurement exercise.

3. Risk Management Issues

The risks associated with procuring food will need to be managed more fully within the Authority including ensuring adequate Food Audits. Support will be required from Environmental Health.
