The report is presented to the Committee in order to comply with the revised CIPFA Treasury Management Code of Practice and CIPFA Prudential Code 2009.
Treasury Management 2016/17 (Q3)	This is a standard quarterly update in relation to Treasury Management
Public Services Board Annual Report 2016	The Committee has a key role to play in monitoring the work of the Public Services Board.
Public Services Board Well- Being Assessment	Council will be asked to designate the Policy & Resources Scrutiny Committee as the Authority's Scrutiny Committee for the purposes of scrutinising the work of the Carmarthenshire Public Service Board and that this function be reflected in Article 6 of the Council's Constitution.
Council's Well Being Objectives 2017/18	The Well-being of Future Generations Act requires most public bodies in Wales to carry out sustainable development with the objective of improving the social, economic, environmental and cultural well-being of their area. It places a well-being duty on those public bodies to set and publish objectives designed to maximise their contribution to the seven national well-being goals. They are also required to take all reasonable steps to meet those objectives. This item will provide the Committee with an opportunity to consider and comment on the Council's proposed objectives for 2017/18.
Procurement Strategy	The Committee has requested that a focus group be established to assist with the review of the Council's Procurement Strategy. This item will provide the main Committee with an opportunity to comment on the revised strategy document.
