BRIEF SUMMARY OF PURPOSE OF REPORT

The Contract Procedure Rules were updated and approved by Audit Committee on 30th September 2016. These Rules have been applied to all procurement activity from this date onwards. In practice, some areas of the Rules have been open to interpretation (most notably in Clause 12 – Exceptions) which has resulted in these suggested amendments for clarity.

Due to ever emerging changes in case law in pubic procurement these Rules will remain a live document and any proposed future amendments will be brought to the Audit Committee for approval.
