### **EVENT SUPPORT FUND APPLICATIONS**

As part of a series of actions to grow the contribution of events and festivals in Carmarthenshire, £20,000.00 has been approved to provide an Event Support Fund Scheme aimed at providing financial assistance to events in the county that can demonstrate that they can make a contribution to the Tourism, Community and Economic strategic aims. As of the 8th July 2017, £9,200 has been committed. The following applications have been received, assessed against the criteria with recommendations listed below

- Chwedlau Caerfyrddin: Recommended support £500.00
- Llandeilo Festival of Senses 2017: Recommended support £1,500
- The Big Cwtch 2017: Recommended support £2,500
- Gar Gwyl 2017: Recommended support £0.00 Total sum recommended £4,500.00 Scheme amount remaining: £6,300.00

Two of these applications are for events in the traditional Peak season and consideration needs to be given to the objective to use events to drive demand into periods of the year when they can make a greater economic or promotional impact. More communication is being done to establish relationships with events that can bring more of a spread throughout the year as well provide more of an impact than those already known.
