## WATER CHARGES AT TY'R GELLI, LLANELLI

#### Purpose

To explain the overpayment of water charges by current and former tenants at Ty'r Gelli Sheltered Scheme, Llanelli.

#### Context

A review of Welsh Water charges within the council's sheltered schemes has identified that Welsh Water has been incorrectly charging the Council for the water supply at Ty'r Gelli from 1<sup>st</sup> April 2010 to 31<sup>st</sup> March 2017. These charges were then used to calculate the weekly water charges for tenants at the scheme.

Following discussions with Welsh Water we have now received amended charges for the identified period. This has resulted in a large number of tenants being entitled to a refund. The refund totals £33,086.42 with the average refund per tenant being £973.13.

Both tenant and former tenants will be refunded the money owed and they will be given the choice as to how they would like the money refunded. Should the former tenant be deceased the money will be repaid to the outstanding estate.

#### **Recommendation:**

• To refund the overpaid water charges to current and former tenants at Ty'r Gelli, Llanelli.
