# LICENSING ACT 2003 REVIEW OF LICENSING POLICY

Carmarthenshire County Council is currently reviewing its Licensing Policy. When the current policy was adopted by the authority in February 2016, it was resolved that as a result of the responses to the 2015 Policy review, a further consultation would be undertaken regarding the possible adoption of a cumulative impact policy in respect of Lammas Street, Carmarthen.

Cumulative impact" is not mentioned specifically in the 2003 Act. In the statutory Guidance, it means the potential impact on the promotion of the licensing objectives of a significant number of licensed premises concentrated in one area. The cumulative impact of licensed premises on the promotion of the licensing objectives is a proper matter for a licensing authority to consider in developing its licensing policy statement. Cumulative impact policies (CIP) may relate to premises licensed to carry on any licensable activity, including the sale of alcohol for consumption on or off the premises, and the provision of late night refreshment. This includes late night fast food outlets which are not licensed to sell alcohol.

The consultation document and response forms are attached and provide further detail regarding cumulative impact and the area under consideration.

The consultation closes on the 1<sup>st</sup> of June 2018.

Responses to the consultation exercise will be collated as part of the final report which is due to be considered by full council on the 12<sup>th</sup> of December 2018.
