### **EXECUTIVE SUMMARY:**

An application was made by Ms Sharon Burdess dated 1<sup>st</sup> March 2017 to register Llanerch Recreation or Playing Fields, Llanerch, Llanelli as a Town or Village Green under S15 Commons Act 2006. The site falls within the administrative area for which Carmarthenshire County Council ('CCC') is responsible, and is also entirely within the freehold ownership of CCC.

CCC, as landowner, was the principal objector to the application.

Following initial advice from Counsel a non-statutory Public Local Inquiry was held at Llanelli Town Hall on  $10^{th} - 13^{th}$  April 2018, with Mr Alun Alesbury being appointed as the Inquiry Inspector. At the Inquiry, submissions were made on behalf of both the Applicant and the Principal Objector, and oral evidence was heard from witnesses on behalf of both sides.

Following conclusion of the Inquiry Mr Alesbury produced a comprehensive report dated 26<sup>th</sup> July 2018, concluding that the Applicant had not made out her case for registration of the application site under S15(2) of the Commons Act, primarily because use of the site by local people was 'by right' or 'with permission', as opposed to 'as of right', as is the requirement under S15(2). He therefore makes the recommendation that no part of the land to which the application relates should be added to the statutory register of Town or Village Greens maintained under the Commons Act 2006, because on the evidence, and the applicable law, it does not meet the criteria required for such registration.
