Purpose

The Energy Company Obligation (ECO) Help to Heat scheme is intended to help fuel poor households who are not in receipt of benefits and low income households that are vulnerable to mitigate the effects of living in a cold home.

The purpose of this report is to outline what steps need to be taken to introduce the (ECO) Help to Heat programme in Carmarthenshire.

What is Energy Company Obligation Help to Heat Scheme?

- ECO is an obligation on energy suppliers aimed to helping households cut their energy bills and reduce carbon emissions. The scheme is the vehicle through which the Government meets its manifesto commitment to tackle fuel poverty.
- Under the scheme the mechanism, allows local authorities to make declarations
 determining that certain households meet the eligibility criteria for a measure under
 the affordable warmth element of ECO. The local authority's role is to support
 administration and determine eligibility. The provision of funding and completion of
 work is dealt with by the Energy Company and their intermediaries.
- This scheme will provide a new opportunity for residents who live in private sector housing. Help is available to households in receipt of means test benefits through the Welsh Government's Nest scheme to make improvements to their heating or insulation. Interest free loans are also available to households under the Council's Home Improvement Loan scheme, funded by the Welsh Government. However there will be many households in Carmarthenshire who would not qualify for help through Nest and would not be able to afford to repay a loan.

How does the scheme work?

The scheme only covers private tenure households, i.e. those in the private rented sector and owner occupiers. Social housing is excluded from the scheme.

The process will involve the following:

- A householder will make an application to their Energy Company or intermediary.
- A referral will be made to the local authority to assess eligibility who release an eligibility declaration.
- The Energy Company or intermediaries organise and fund the work.



The type of improvements that can be made to people's homes include new or upgrades to heating systems and/or insulation measures. These improvements will be funded by energy suppliers and installed by energy suppliers or their intermediaries.

In order for households in an area to benefit from the scheme the local authority must publish a Statement of Intent (see attached). This sets out the criteria they intend to use to identify households meeting the eligibility criteria.

Ceredigion and Powys councils are currently operating this scheme and Pembrokeshire are due to introduce the scheme using similar eligibility criteria. In order to achieve consistency across the region it is proposed if the scheme is introduced in Carmarthenshire that the same eligibility criteria be applied. In summary the proposed eligibility criteria are:

- 1. The property must have a poor rating (E, F or G) on an Energy Performance Certificate (EPC) **or** score over a certain figure on the property condition questionnaire; **and**
- 2. The household must declare they spend more than 10% of their income on fuel costs **or** a member of the household must be vulnerable and at risk due to living in a cold property.

There will be some administration required by the Home Improvement Team in determining the eligibility of the household/property and to publicise the scheme. Therefore it is proposed that a fee for this work will be charged to the Energy Company or its intermediary. Ceredigion and Powys are charging £150 per eligible household and it is proposed Carmarthenshire charge the same.

Under the scheme the Council will not retain any responsibility for the work that is undertaken as the work is not being specified or procured by the Council. The householder will receive the appropriate warranties and guarantees from the Energy Company or its intermediary direct.

In order to ensure compliance with data protection rules and the General Data Protection Regulations, the Council will enter into data sharing agreements with those Energy Companies / intermediaries who wish to provide improvements in Carmarthenshire.

After consultation with other local authorities it is proposed to charge £150 per successful referral. This is reflective of the work involved and that charged throughout the region.

The fee is paid by the Energy Company and will support existing income targets.

5. Risk Management Issues

If we don't take part in the Help to Heat scheme then our residents will not be allowed to access this funding as the scheme would need to be endorsed by the Council.

The work is not specified or provided by the Council.

The responsibility for selecting the Energy Company is placed on the occupier. The Council's main role involves assessment of eligibility. The Energy Company or intermediaries are responsible for the completion of work and issuing appropriate guarantees.
