**WELSH GOVERNMENT CONSULTATION ON REFORMING THE LICENSING
OF TAXI'S AND PRIVATE HIRE VEHICLES IN WALES**

At the Licensing Committee Meeting on the 8th January 2019, members were informed of a recent Welsh Government Consultation paper titled "Improving Public Transport".

This is a Welsh Government White paper on proposals to legislate for reforming the planning and delivery of local bus services and licensing of taxis and private hire vehicles.

Part of this this consultation sought views on proposals in relation to reforming the Licensing of Taxis and Private Hire vehicles. This included the proposal to redirect all of the existing taxi and PHV licensing functions away from the local authorities and into a national licensing authority, a JTA. (Joint Transport Authority)
