Budget Monitoring 1 April 2018 – 31 December 2018

BRIEF SUMMARY OF PURPOSE OF REPORT

The position as at 31 December 2018 was an under spend compared to budget of £2,815k on cash items.

Expenditure

The net effect of Benefits Payable and Transfers Out is an over spend of £258k. This is mainly influenced by the un-controllable nature of lump sum payments and transfers out of the Fund. Management expenses are underspent by £37k.

Income

The net effect of Contributions, Investment Income and Transfers In is an under spend of £3.0m.

Total expenditure was £86.7m and total income was £89.5m resulting in a positive cash flow position of £2.8m.
