EXECUTIVE SUMMARY

STANDARDS COMMITTEE

14TH JUNE 2019

CODE OF CONDUCT TRAINING 2019

The Standards Committee has hosted annual code of conduct training sessions for Town & Community Councils for several years.

At the meeting of the Standards Committee in March 2019 committee members expressed concern that, despite these efforts, a significant proportion of Town & Community Councillors had not undertaken any code training during the last 5 years.

Subsequently committee members resolved to hold 2 such training sessions July 2019, in Llanelli on the 10th and Carmarthen on the 16th.

Invitation letters were sent to all Town and Community Councils on the 3rd May 2019 requesting a response by the 14th June.

As at the date of writing this report, responses have been received from 14 councils. Of these;

- One council has indicated that they will not be taking up the offer of training as members have recently received training from One Voice Wales.
- One council has booked places for the training session in Llanelli on the 10th July (3 delegates in total)
- Thirteen councils have booked places for the training session in Carmarthen on the 16th July (53 delegates in total)

To date, no invitation has been sent to County Councillors, in order to allow Town and Community Councils to maximise their take up of spaces.
