# EXECUTIVE SUMMARY EXECUTIVE BOARD MEMBER DECISIONS MEETING FOR ENVIRONMENT 19<sup>TH</sup> JULY 2019

### RECYCLING CONTAINER PROVISION

In order to support the transition of recycling material from the black-bag into the recycling streams we will continue to deliver rolls of blue bags to all households across the county with the annual delivery programme commencing in September.

From an analysis of black bags it has been observed that 25.8% of the black bag content in Carmarthenshire is food waste. Feedback from the recent Household Waste and Recycling Service Consultation identified that of the respondents who said that they do not currently recycle their food waste, 64% said that they would be more likely to do so if they were provided with free liners. From kerbside collection monitoring it has been observed that our current household food waste recycling participation does not exceed 50% at present.

At present Carmarthenshire is the only Authority in Wales not to provide food waste liners to residents. To further support the transition of food waste from the black-bag into the food waste recycling scheme, we propose to deliver food waste liners to all householders at the same time as the blue recycling bag delivery programme.

Last year as an Authority we recycled 6,701t of food waste equating to 75kg per household (HH) per year averaged over 89,688 households which is below the Welsh rural and national average. The better performing authorities in Wales collect around 100 kg per household per year with the highest performing collecting 120kg. If we were to improve performance to 100kg per HH per year our overall recycling tonnage would be 8,968t an increase of 34%. When we focus solely upon the participating households the average food waste recycled is 149kg per participating household per year.

The estimated costs of supplying food waste liners to all households is approximately £215,000 and is dependent upon a procurement process and will be funded from within departmental resources. A marginal increase in container delivery costs may be experienced due to the increased time in delivery for two separate containers. But delivery costs would be incurred anyway through the delivery of the blue recycling bags to households.



If we were to assume that based on the information received from our survey that 64% of the household that currently do not recycle food would do so with a liner the participation of the scheme may rise to:

- Current participating HHs: 89,688 HH x 50% = 44,844HH
- Potential HH increase with food liners: 44,844HH x 64% = 28,700HH
- Potential participating HHs: 44,844HH + 28,7000HH = 73,544 HH
- Potential percentage HH participation 82%.

When assuming that participating household currently recycle 149kg per year the total recycled food waste could potentially grow to 10,958t per year. This is obviously a very ambitious growth in food waste. So to be conservative if we were to assume a range of performance between achieving 25% -50% of this tonnage it would mean and increase of between 1,064t and 2,128t of food waste per year. Resulting in a conservative estimate increase in our overall recycling rate of between 1.29% and 2.6%.

In terms of treatment costs alone this increase in food waste would result in an approximate decrease in overall treatment spend of between £58,520 and £117,040 per year. The greater risk would be if we were to miss the statutory target of 64% in 2019/20 by the 1.29% increase identified the council would be fined in the region of £212,000.

In addition to the financial implications of this provision operational benefits are likely to be realised also. At present due to loose food being collected and deposited within the pod of the vehicle uneven load distribution in this pod results in the vehicles having to undertake tipping of this load when not at tonnage capacity. We are also experiencing food pod and panier mechanical faults leading to vehicle breakdowns; a reason identified for this is the build-up of food in the lifting mechanism from over-spilled food stored loose within the food caddies. From anecdotal information from other Authorities the containment of food in liners significantly reduces these issue, improving the efficiency of the collection and reduction in vehicle breakdowns.

In conclusion, to further support the transition of food waste from the black-bag into the food waste recycling scheme and increase the overall recycling performance, we propose to deliver food waste liners to all householders at the same time as the blue recycling bag delivery programme.
