### 1. BRIEF SUMMARY OF PURPOSE OF REPORT

In July 2018 Council resolved to adopt the Highway Asset Management Plan which included an undertaking to present an Annual Statement Report on the condition and performance of the highway network and to include investment options, and their implications on the asset condition, within the report.

The Annual Statement Report 2019 includes an overview of the highway network and then details three key asset areas of:

- Highways (carriageways, footways and cycleways)
- Bridges and Structures
- Highway Lighting and Traffic Signals

The report details for each asset category its condition, how its condition has changed and will change into the future depending on funding scenarios which are set out within the report.
