# APPLICATION FOR DISPENSATION BY COUNCILLOR DOROTHY JONES

A dispensation application has been received from County Councillor Dorothy Jones to speak and vote in respect of any council business relating to the provision of home to school transport, in particular proceedings of the advisory panel established by the Executive Board to look into this issue, of which Cllr. Jones is a member.

Councillor Jones would have a personal interest in such council business by virtue of paragraph 10(2)(b)(i) of the members code of conduct as she is the parent of school age children living in the County. This personal interest would also be prejudicial as a member of the public with knowledge of the relevant facts would reasonably regard the interest as so significant that it would be likely to prejudice the Councillor's judgement of the public interest.

Councillor Jones has submitted her application on the basis of three grounds set out in the Standards Committees (Grant of Dispensations)(Wales) regulations 2011 (as amended) namely;

- 1. That the nature of her interest is such that her participation in the business to which the interest relates would not damage public confidence
- 2. That her interest is common to a significant proportion of the general public
- 3. That her participation is justified by her particular role or expertise.

If the committee is minded to grant Councillor Jones a dispensation in respect of this interest it has absolute discretion as to the duration of that dispensation.
