DELEGATING AUTHORITY TO OFFICERS

At the meeting of the Licensing Committee held on the 19th May 2016, members resolved that consideration be given to the possibility of delegating authority to Officers to issue certain licenses under delegated Authority.

1. Drivers over 70 years of age

Currently where applicants reach the age of 70, they must appear before the Licensing Committee in order for their Licence to be issued. This is as a result of Condition 25 of the Council's Conditions of Licence for Hackney Carriage and Private Hire Dual Drivers which states that "The driver shall be at least twenty one years of age and must not be older than seventy years of age"

2. Exemption from Condition 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles

Currently where an application is made to operate a vehicle for executive type hire, applicants appear before the Committee to request an exemption from Condition 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles, namely that the applicant be not required to display door stickers and a licence plate on the rear bumper of the Vehicle. In order to be granted this exemption, applicants must submit a business case to the authority and appear before committee for each vehicle they request this exemption.
