The Welsh Language (Wales) Measure 2011 is the legislation that created the Welsh language standards.

Welsh language standards promote and facilitate the Welsh language and ensure that the Welsh language is not treated less favourably than the English language in Wales.

The Welsh language Standards aim to:

- Provide clarity to organisations on their duties on the Welsh language in terms of Service delivery, Policy making, and internal operations, as well as their duties to promote the Welsh language,
- Provide clarity to Welsh speakers on the services they can expect to receive in Welsh
- Ensure more consistency of Welsh language services and improve their quality.
