

Further to the receipt of the above application, the Licensing Authority make the following representations:

a) Previous Enforcement Action / Prosecutions

The premises has been licensed by the authority since 2005. The file indicates one warning letter issued in 2010 to a previous licence holder regarding a failure to comply with a door supervisor condition attached to the licence.

b) Complaints.

There have been no other complaints received by the licensing authority in relation to these premises.

c) Responsible Authority Referrals.

The licensing authority has received a referral from the Police in 2010 relating to the matter outlined in section a) above. Following receipt of this application, the authority has received correspondence from planning services, which is attached to this letter, stating that the current planning permission does not allow the premises to be open to customers between 12.30am and 10am the following day. I would ask the applicant to outline what steps have been taken to address this matter.

d) Relevant Sections of the Statutory Guidance.

The Licensing Authority believes that the following sections of the Statutory Guidance are relevant to this licence application: - Section 1 Introduction, Section 2 relating to The Licensing Objectives, Section 5 relating to Premises licences, Section 8 relating to Applications for Premises Licences and Section 10 relating to Licence Conditions.

e) Relevant Sections of the Local Licensing Policy.

The Licensing Authority believes that the following sections of Carmarthenshire's Licensing Policy are relevant to this licence application:- Section 3 Fundamental principles, Section 4 Conditions of Licence, Sections 5 – 9 relating to The Licensing Objectives and Section 11 relating to Licensing Hours.

f) Proposed Operating Schedule.

The operating schedule submitted as part of the application indicates that the applicant proposes to operate in accordance with the conditions attached to the existing licence.

Having considered the other statements contained in the operating schedule put forward by the applicants, the Licensing Authority believes that, if the application were granted, the wording set out in the operating schedule, is not sufficiently precise to enable it to form clear enforceable licence conditions in accordance with section 18(2)(a) of the Licensing Act .

I note that a number of letters of representation, opposing the grant of the variation have been received from local residents and their representatives. These letters raise concerns regarding the promotion of the licence objectives if the variation is granted and some letters state that residents of the adjacent residential units are already affected by noise and disturbance as a result of the premises operating in accordance with its existing permitted hours. The subcommittee will have to be satisfied that granting the variation application will not undermine the licensing objectives, including the prevention of public nuisance.

The applicant has indicated on page nineteen of the application form that a risk assessment has been undertaken in relation to the effect of the variation application and are satisfied that no new steps have been identified as necessary to promote the licensing objectives. In view of the representations received, I would request that the applicant provides a copy of the risk assessment as suggested in section 5.4 of the Licensing Policy. In addition I would request that the applicant sets out in detail the control measures they intend to put in place to deal with the matters raised in the letters of representation as suggested in paragraph 5.5 of the Licensing Policy.

The Dyfed Powys Police have also submitted representations requesting that additional conditions be attached to the licence should the variation application be granted. If the variation application is granted I believe it would be appropriate to attach the conditions numbered 1 – 21, requested by the Police.

It would also be appropriate to remove existing conditions b) 1-3,7,9-12 to avoid duplication.

These representations have been prepared on the 19th of August 2015 with the benefit of viewing the original application and representations from the Police, local residents and their representatives.

I would be grateful if the applicant could contact me to discuss the above representations at the earliest opportunity and certainly prior to the application being referred to a Licensing Sub Committee hearing for determination.

13. No person under the age of 18 shall be employed on the premises whether paid or unpaid for the purpose of serving alcohol.
14. No children under the age of 16 years to remain on the premises after 22:00 unless they are attending a pre-booked event or function and in the company of a parent or responsible adult.
15. Door supervisors to be on duty whenever Regulated Entertainment is provided after 11pm.

The applicant to also risk assess the use of door supervisors at all other times for Regulated Entertainment, if provided before 11pm. especially on Bank Holiday weekends, Christmas Eve, Boxing Day and New Year's Eve and major televised sporting events.

When employed Door Supervisors must be registered with the SIA, to be on duty until the time that all members of the public have left the premises.

The Licence Holder shall supply an appropriate number of Door Supervisors for the maximum occupancy figure stated in the licence and the appropriate number shall be 2 in respect of the first 100 persons and one for each additional 100 persons or part of 100 persons comprised in the maximum occupancy figure.

Door Supervisors shall not be permitted to consume intoxicating liquor or other Intoxicants during any period of duty at the Premises. A Door Supervisor shall report on duty in a sober condition.

The Designated Premises Supervisor or Premises Licence Holder shall nominate for each and every exit door a Door Supervisor who's duty it shall be to ensure that the exit door is opened immediately in the event of a Fire or other Emergency and if practicable no more than one door shall be designated to each Door Supervisor.

No Door Supervisors shall be engaged in any duty that would otherwise prevent him, carrying out his duty as a Door Supervisor or exercising general supervision and control of persons attending the Premises.

Door supervisors to remain on duty after Regulated Entertainment ends until permitted hours in respect of the supply of alcohol finishes.

Hello,

I am writing to voice my opposition to the proposed extended hours license application for Chillies Diner and Mojitos Bar. I am a resident of the Pugh Building, living on the first floor, and if this goes ahead my quality of life will suffer as a result. I work flexible shifts, so regularly work Saturday and Sunday Mornings, and to have loud music playing downstairs until 3am is ludicrous, it is supposed to be a restaurant and bar, and not a nightclub. I am a young person myself, and understand people like to go out on the weekend, but having what is essentially a nightclub, below residential flats, with no soundproofing is unacceptable. I don't mind live music or recorded music being played until 11pm, as like when the Bidding was below, but what is being proposed is ridiculous.

It was bad enough when Rendezvous was downstairs, and loud music was being played below until 1am on the weekend. It got so bad at times I had to resort to wearing ear plugs in my own flat, and using sleeping pills to be able to get to sleep. I am blind in one eye, and losing sight in the other, so my hearing is of the utmost importance, and it is unfair if I have to listen to unacceptably loud music into the early hours.

On top of this also comes antisocial behaviour. When Rendezvous was downstairs, I would often open the front door to get out of the building to be confronted by excrement and vomit, people going outside for cigarette breaks also use the alcove right below my window, and the smell of stale cigarette smoke coming into my flat is unacceptable.

If this goes ahead I will have to seek legal advice as believe this will be an infringement on my human rights.

Notice of Objection.

I am the appointed Managing Agent for the building known as Pughs Building 17-25 Cowell Street, Llanelli, which includes the above named licensed premises in addition to Ladbrokes Betting Shop and the 30 Residential flats known as Pughs Loft Apartments, situated immediately above the two commercial premises on the ground floor of the building. These flats are owned by the leaseholders company PB Residential Limited which is wholly responsible for the communal areas of the building and for which I am the appointed Company Secretary.

I wish to have my objection to the Licensed hours extension for the premises known as Chillies Diner & Mojito Bar noted. The grounds for my objection are as detailed below.

The area is adequately served with late night entertainment venues, with the MET bar, Mayhem Night Club (previously Kandy Bar) and Storm Night Club (previously Tom Peppers) all within 100 metres (Mayhem and MET) of the premises application.

The lease on this premises which commenced on 31st July 2015, as signed by Morgan and John Leisure Limited (the applicants for License variation) and Greenday Properties Limited (The Landlord) clearly specifies the use of the premises as a Public House and/or Restaurant within the use Class 3 of the Town and Country Planning Order 1987 – or such other use as the Landlord may confirm in writing. In this case the applicants have made no request of the Landlords to change the specified use of the building to one of Late Night Refreshment House, which had they done so would not have been permitted due to the close proximity to the residential units where a number of families, some with young children, are living. Our objections to any hours extensions were clearly voiced to the new tenants prior to their acceptance of the lease on this premises.

Clause 3.10.1 States that the Tenants (Morgan & John) may not do or permit to remain upon the premises or any part thereof anything which may in the opinion of the Landlord be or become a

nuisance, annoyance, disturbance, inconvenience, injury or damage to the Landlord or their respective tenants or the owners or occupiers of any property in the neighbourhood.

Clause 3.10.2 States in part that they may not use the Premises or any part thereof for any noxious, noisy or offensive trade or business..... nor for any public exhibition or show.

Clause 3.11 - Use. At all times during the term of the lease to use the premises for the Specified Use and not to use same for any other purpose. (I note the request to show films which would be at variance to the lease and prohibited). The specified purpose being a Public House and Restaurant and not a Late Night Refreshment House, Karaoke Bar, Night Club or any other such use.

Clause 3.14.1. Not to do anything on the Premises which may render any increased premium payable for the insurance of the premises or nearby premises, or which may make void any such insurance policy. – Clearly operating as a late night club will increase the Insurance risk and thus would invalidate the lease.

The above points clearly point to the applicants being in Breach of the terms of their Lease which they had duly signed some four weeks ago.

Whilst researching the applicants and their proposal for increasing the hours until 3am, certain information has become apparent in relation to The Railway Inn, Derwen Road, Bridgend CF31 1LE, this being a premises operated by Michael John, one of the applicants in Morgan & John Leisure. The operating hours of that licensed premises were extended and a licence issued on 22nd December 2009. From that time it became apparent that a number of incidences of drunkenness, disorder and violence were apparently recorded at or very close to The Railway Inn, including GBH, ABH, Damage, Drunkenness, Drugs, Fighting and Riotous behaviour, Indecent Assault, Overcrowding and many alcohol related incidents, mainly occurring after midnight up to and including the 3 am extended licence closure times. It is alleged that Mr John was actually in receipt of a Final Warning with regard to alcohol sales during the period after the variance of his operating hours.

Given the above facts I believe that the public in Llanelli would not be best served by the granting of the variance to the hours of operation of Chillies Diner & Mojito Bar. In fact refusal to grant this application would serve to prevent increased crime and disorder in the town centre, an area which is central for the control of Public Safety, for the prevention of public nuisance and to prevent and protect children from being exposed to harm.

I am prepared to attend any mediation meeting or any other such determining meeting to state my objections as outlined.

It is of direct concern to the above flat owners that extended licensing hours for the pub premises would seriously affect the ongoing letting (and similarly any potential sale) of their properties.

Our sister company, Dragon Estate Management acts as block manager for PB Residential Limited, representing the group of owners of 30 apartments situated directly above the premises.

The fact that the apartments are situated above a public house already has a negative effect on their appeal to prospective tenants. However following initial discussions held between our company and leaseholder Mr Robert James prior to the premises opening, we were assured that there would not be any application for licensing later than midnight in order to avoid any potential problems for residents in the building.

The main reasons for objection are as follows:

1. A level of continual nuisance noise from people congregating to smoke or gather in front of the pub premises is already experienced until midnight by the residents. At least 18 apartment windows (many of which are bedroom windows) face the front of the building (some just 10ft above the pub main doors) and are subject to late night noise on a regular basis. To extend pub opening hours would be damaging to the wellbeing of the current residents and ultimately to the prospects of these flats being occupied.
2. Regular occurrences of late night revellers leaving bottles of alcohol and unfortunate incidents of vomit on the Pugh Building apartment doorstep have been an unpleasant consequence of the close proximity of the pub and apartment entrances over the years. These incidents will inevitably increase with extended hours for supply of alcohol.
3. Further to Point 2 above, the serving of alcohol until 3am is also highly likely to increase the levels of anti-social behaviour due to excessive drinking, disturbance and general intimidation faced by residents entering or leaving the apartments. Bearing in mind that the Pugh Building apartments are now primarily occupied by professionals and young families, this would be an extremely damaging situation if permitted by the council.
4. The pub unit has a number of large air conditioning units affixed to the back of the building which create a low level noise and vibration audible inside the rear facing flats. Residents are used to experiencing this until approximately midnight at the latest.
5. Pub staff regularly use the rear doors of the unit whilst on smoking breaks, putting out waste / bottles etc. This area (including their trade waste bins) lies just below the flat windows, it would be unfair to subject residents to such noise at unsociable hours when they would expect to benefit from at least 6 hours of uninterrupted quiet before morning.
6. It is a fact that the vibrations and bass notes of live music played in the pub unit can be felt strongly through the floors of the 9 first floor flats at Pugh Building. It is therefore imperative that live music is not played beyond reasonable hours of 11pm and on weekends only.

If the owners of the Pugh Building apartments are no longer able to let their properties to appropriately employed tenants and families then this will create a situation of vacant flats appealing to a very limited market of tenants whose lifestyle is conducive to late night revelling, and by default a very negative social balance in a prominent town centre building. In conjunction with Dragon Estate Management, Carmarthenshire Council and Dyfed Powys Police and have worked hard to avoid this exact situation over the past 7 years.

Given the above points it is our strong belief that midnight is sufficiently late for the venue to be serving alcohol and providing late night refreshments when it is located in such close proximity to 30 tenanted apartments. We trust that the Council will carefully consider the extremely negative implications of granting any extended licensing hours to Chillies Diner & Mojito Bar.
