**2. TO SIGN AS A CORRECT RECORD THE DECISION RECORD OF THE MEETING HELD ON THE 3RD AUGUST 2015**

**RESOLVED** that the decision record of the meeting held on the 3rd August 2015 be signed as a correct record.

**3. Application to Divert Byway Open to All Traffic (BOAT) 57/42 at Bryndias Farm, Pinged, made under section 117 of the Highways Act (1980) for reasons of security and for public safety.**

The Executive Board Member considered an application to divert a Byway Open to All Traffic (BOAT) 57/42 at Bryndias Farm, Pinged, made under section 117 of the Highways Act (1980) for reasons of security and for public safety. The application satisfied the test laid out in section 116 of the Highways Act 1980 (under which the Diversion Order would be made), namely that it would be more commodious to the public as it would remove the BOAT from the residential curtilage of Bryndias Farm and reduce the overall number of gates on the route from 5 to 3. Two objections received had later been withdrawn following further explanation and some amendments to the proposed width.

**RESOLVED** that the application be approved and that the necessary Notice of Application be heard at the relevant Magistrates Court.

**5. PROHIBITION ORDERS IN RELATION TO LONG DORMANT MINERAL WORKING SITES**

**Following the application of the public interest test it was RESOLVED** pursuant to the Act referred to in minute no. 4 above not to publicise the content of the report as it contained exempt information that reveals that the Authority proposes to make an Order or Direction under any Enactment (Paragraph 17 of Part 4 of Schedule 12A to the Act).

The public interest test in this matter related to the fact that the report contained details of proposed Orders to be made by the Mineral Planning Authority to prohibit the resumption of mineral working at particular sites within the County, subject to confirmation by the Welsh Government. Disclosure of the proposed sites at this time is likely to undermine the administration of justice, and therefore on balance the public interest in disclosure is outweighed by the public interest in maintaining confidentiality.

The Executive Board Member considered a report which recommended the serving of Prohibition Orders in relation to a number of long dormant mineral working sites so as not to perpetuate historical and unsustainable patterns of supply and to ensure that supply was managed in a sustainable way and struck a balance between environmental, economic and social considerations.

**RESOLVED** that Prohibition Orders be served in relation to the sites referred to in the report in order to prevent the resumption of winning and working of minerals thereat.

Xcel addresses economic inactivity within the community and has created 30 salaried jobs and supported 100 Volunteers.</p> <p>Realistic financial profiles from the onset indicated its commercial viability and phase 2 will be partly funded via the profits from the bowling enterprise.</p> <p>TFF funding is required spearhead the regeneration of Phase 2 which will include office and meeting space, conference centre/auditorium and commercial standard kitchen.</p> <p>The grant will allow Xcel to install an <b>efficient heating system</b> in the phase 2 office and meeting space which will allow Xcel to let a warm, welcoming, fit for purpose environment to clients, beneficiaries, community groups and businesses. This suite consists of 4 meeting rooms and a 30 seat seminar room which could be used for conferencing and training. Income from this element along with phase 1 income streams will be reinvested into community activities and contribute towards the phase 2 redevelopment costs.</p> <p>The old heating system was uninstalled when the cheese factory closed some 13 years ago. A new low energy and efficient system is essential to enable the office and meeting space to become habitable and thus a viable income generating aspect of the Xcel project.</p> <p>Towy Community Church will be responsible for the maintenance of the heating system after the initial 5 year guarantee has finished.</p>

Members were very complimentary about the site visit and economic and social benefits of the project.</p> <p>Jonathan Fearn – Head of Corporate Property</p> <p>Cllr. Jeff Thomas - Carmarthen Town South</p>
<p><b>Evidence of Need / Community Engagement</b></p>	<p>Xcel has been developed in response to identified need for quality services via extensive community consultations – Petitions, Questionnaire, Letters of Support, sample Surveys, Facebook posts, Trip Adviser comments, customers feedback.</p> <p>There is no other low cost charitable meeting space in the vicinity of Johnstown, this will be a new service to the project adding another income stream to the bowling alley, furniture and charity shop.</p> <p>Towy Community Church and project Xcel (now in its third year) have a proven track record of delivering on social objectives in the local community:</p> <ul style="list-style-type: none"> <li>• Foodbank - over 5000 people have received emergency food aid</li> <li>• Xcel Furniture - over 200 people have benefitted from low cost furniture, and nearly 100 tonnes recycled therefore reducing the amount being sent to landfill</li> <li>• Over 150,000 visitors to date</li> </ul> <p>The project seeks to benefit this community and the neighbourhood by associating together with the community, local authority and voluntary organisations. This common effort advances education; provides facilities in the interest of social welfare, for healthy recreation and leisure time occupation with the objective of improving access to services for the locality. <p><b>Contributing to key Strategies</b></p>	<p>Xcel aims to address the economic, social and environmental needs of Carmarthenshire and addresses the priorities of local, regional and national strategies, namely the City Region Economic Regeneration Strategy and Integrated Strategy for Carmarthenshire for 2011-2016:</p> <p>Making the offices in Phase 2 of the project habitable will reduce sickness levels at the project (it is severely cold in the winter) but also provides valuable income for the project enabling the other aspects like the Foodbank to continue to meet the needs of those in distress, thus helping their wellbeing and health.</p>

	<p>If the facility can be refurbished by installing a heating system it can then be used by the community as meeting space and for training purposes. It will give the community a safe, clean and friendly community focussed environment, a welcoming facility for local engagement and learning. The conference suite consists of 4 meeting rooms and a 30 seating seminar room which could be used for conferencing and training.</p> <p>The latest STEAM report conservatively estimated that the Xcel project has so far contributed over £2 million a year to the local economy. The team will continue to swell this figure. If they are able to install a heating system to the office suite of Xcel Phase 2 their business forecast estimates the conference suite will bring an extra <b>£409,764.00</b> to the project over the next 5 years. Bringing even more business and added spend which contributes towards a stronger and more prosperous Carmarthenshire.</p>
