

It is now the largest single-issue consumer group in the UK, and is a founding member of the European Beer Consumer Union. CAMRA supports responsible drinking and believes that traditional well run pubs perform an important social function in both urban and rural communities. It does not have charitable status

During 2018 Evan Evans brewery submitted a planning application in relation to their Llandeilo site. As a member of the Local Planning Committee I discussed any possible conflict of interest between my CAMRA membership and my role on this committee, with the Council's legal team. I was advised that because of CAMRA's promotion of real ales, which are brewed on the Llandeilo site, I had a personal and prejudicial interest in this planning application. Thus, I did not take part in any proceedings relating to this application, leaving the council chamber when this application was discussed and voted on.

I feel strongly however that the public's confidence in the conduct council business such as this would not have been undermined had I been allowed to participate.

Although I have been a CAMRA member for many years I do not attend any local or national CAMRA meetings, nor do I participate in any promotional or fund-raising activities. My interest is solely as a CAMRA member and as a supporter of real ale.

Interest in, and support for the brewing of, traditional real ale is not confined to CAMRA members. It would seem perverse that a Councillor who shares the views and objectives of CAMRA, but was not a member of that organisation, would presumably have been able to participate in the above mentioned council business, but I was not.

Carmarthenshire County Museum is located in Abergwilli on the outskirts of Carmarthen. It is managed by the County Council.

The museum is housed a building that began life as a college of priests, founded in the 1280s, which then became the palace of the Bishop of St Davids between 1542 and 1974. It was here that the New Testament and the Book of Common Prayer were first translated into the Welsh language in 1567 during the episcopate of Bishop Richard Davies.

The museum tells the rich history the county through a diverse collection of artifacts, paintings and portraits. In addition there is a notable collection of Welsh furniture and costume, a Victorian era village schoolroom, articles associated with the county's farming and agricultural heritage and an exhibition on World War II's home front.

The Friends of the museum, which doesn't have charitable status, were formed in 1989 by a group of people interested in museums and galleries and aware of the difficulties which faced many of them at that time. Membership soon reached 300 and the Friends continue to donate gifts of objects which the museum staff wished to add to the collections. Over the years Friends have planted trees and flowering bulbs to enhance the grounds. A small group of Friends meets regularly to undertake cataloguing of parts of the collections. A varied programme of events takes place throughout the year, ranging from talks on a wide variety of topics and musical evenings, quizzes and discovery trails. A regular newsletter is published.

My wife and I have been members for many years and usually attend meetings that have guest speakers. However we do not participate in any promotional or fund-raising activities.

I am concerned that without a dispensation I may not be able to participate in Council business relating to the museum.

I do not believe that my participation in such business would undermine public confidence. Support for the museum is not limited to those who are members of the 'Friends'. It would seem perverse that a Councillor who supports the continued existence of the museum but is not a member of the 'Friends' would not have a prejudicial interest in council business relating to the museum, but I may well have.

The Heart of Wales Line runs from Craven Arms on the English border to Llanelli, serving a number of towns and villages in Carmarthenshire, particularly, Llandovery, Llandeilo and Ammanford and providing these communities with their only connection to mainline services at Swansea and Shrewsbury. The line is therefore very important to the places that it serves.

The line has been under regular threat of closure since the 1960's and HOWLTA was formed for the purpose of promoting the line, lobbying for suitable services and encouraging people to use it so it is available for the travellers of the future. It does not have charitable status.

I have been a member of HOWLTA for over forty years but I do not attend meetings at a national or local level, nor do I participate in any promotional or fund-raising activities.

I am concerned that without a dispensation I will be unable to participate in any council business relating to or likely to affect the line. This might include planning applications, grant applications from community groups and discussions relating to UK and Welsh Government consultations on public transport provision generally and the future of the line in particular.

I have been a member of UNISON's retirement section following my retirement in 2016. Prior to this I was a full-time member from July 1997. I do not, nor ever have, held any officer role in UNISON.

In 2018 I wanted to submit a motion on behalf of the Labour Group urging the County Council to adopt UNISON's Ethical Care Charter for the commissioning of home care services. However, after taking advice from the Council's legal section I was advised that my membership of UNISON meant that I would have a prejudicial interest in any such motion. As such I did not proceed.

I feel strongly that promoting such measures is an important part of my role as a Labour councillor and it is disappointing that I should be prevented from doing so simply because I am a member of a trades union which is closely affiliated to the Labour Party.

UNISON has over 1.3 million members across the UK (over 100,000 in Wales) and its main purpose is to represent the interests of public sector workers, including those in local government. I do not believe that my participation in such business would damage public confidence. Indeed I believe that this is the sort of thing that local residents elected me to do.

There is a high proportion of public sector workers in Carmarthenshire, many of whom are UNISON members. I therefore believe that my interest is common to myself and a significant proportion of the public.

Firstly, I would like to point out that, although I have indicated that I would like to speak and make written representations, I would be satisfied with either one and only wish to make whichever is deemed appropriate by the Standards Committee (if any).

The primary reason that I wish to speak on the matter of candidate sites is because of my local and general expertise. In general terms, I am a member of the Key Stakeholder Forum for the Revised LDP and am in all probability the only member of the Community Council who has consulted every published document related to the Revised LDP. I therefore possess a good knowledge of the LDP revision process.

Similarly, my profession is that of a PhD researcher, whereby my thesis concerns case studies in historic environment policy in Wales and Quebec. The Welsh case study requires me to understand and have a good knowledge of how the planning system relates to historic environment matters that includes a substantial crossover with subjects relevant to the LDP revision process. Therefore, I would venture to suggest that my theoretical and procedural knowledge of the planning system and ability to assess evidence to an academic standard is unique on the Community Council, whereas the knowledge of other Councillors tends to be based upon personal and professional experience (e.g. construction, renovation etc).

Using this expertise I would like to speak about three general points that indirectly relate to the candidate sites in question. I wish to share my research into the potential consequences and implications of City-Region Deals (due to the Swansea Bay Deal occupying a prominent position in the draft Preferred Strategy); contribute analysis on the assumptions underlying the population forecasts made by Edge Analytics; and to contribute analysis on Salem's designation as a sustainable village. I believe that I would make these contributions irrespective of any candidate sites close to my property and that these contributions may be enlightening and relevant for other Councillors to hear.

In terms of local expertise, I am one of only two Community Councillors based within Salem village, and am the only one based close to the candidate sites in question. It is here worth noting that other residents adjacent to the sites share the same preferences as myself and wish their views to be represented. But in order for the Standards Committee to make an informed decision I believe that it is important to acknowledge and reiterate my own personal interest clearly: my preference and the preference of my family would be for there to be no residential development allowed on the candidate sites in question. If the Standards Committee decides that this preference renders me ineligible to speak or make written representations then I would entirely understand. I have absolutely no wish to unduly influence a fair and open process.

If allowed to speak I would like to contribute a critical analysis of the candidate sites in question based upon the following factors:

- Access to the site for emergency services, construction vehicles, and potential residents
- Provision of public transport in the area and its implications for the candidate sites and the wellbeing and strategic objectives included within the draft Preferred Strategy
- Provision of infrastructure and services in the area and its implications for the candidate sites and the wellbeing and strategic objectives included within the draft Preferred Strategy
- The environment and wildlife in the area and their implications for the candidate sites and the wellbeing and strategic objectives included within the draft Preferred Strategy
- Alternative suggestions and sustainability in the area and their implications for the candidate sites and the wellbeing and strategic objectives included within the draft Preferred Strategy

I believe that these matters would all be relevant and useful for the Community Council to hear and would be consistent with the contributions that I and others have previously made to planning applications viewed by the Community Council. I should be happy to listen and discuss the views of other Councillors on the matter and would accept any decision of the Community Council without argument no matter which way it was made.

I hope that I have outlined enough detail and information for the Standards Committee to make an informed decision and that you will please consider my request for dispensation favourably. Thank you very much for your time and consideration.
