OBJECTIONS TO THE COUNTY OF CARMARTHENSHIRE - WAITING RESTRICTIONS AND STREET PARKING - (AMMANFORD) (VARIATION 14)

BRIEF SUMMARY OF PURPOSE OF REPORT

Purpose

This report is to determine objections received to the proposed on-street waiting restrictions in Ammanford. Full details of the proposed restrictions are listed in **Appendix 1** and **Appendix 2** of the report. The purpose of the proposed restrictions is to safeguard road users, to facilitate the safe and unhindered passage of traffic and to support local communities.

Consultation

The advertised proposals are listed in **Appendix 1**.

Objections and comments

During the consultation period the Council's Head of Administration and Law received three objections and a 32 name petition against the advertised proposals. These objections are summarised in **Appendix 3** along with officer comments and recommendations.

In brief, the objections are explained below:

- i. **Limited waiting, Quay Street** - Introduce a 1 hour limited waiting bay, Mon-Sat, 8am – 6 pm, no return 1 hour.

The objector is concerned that the proposals would cause chaos.

Recommendation: Implement the proposals as described in **Appendix 1**.

- ii. **Maesquarre Road** - Introduce a prohibition of waiting at any time at its junction with Maes Ifan.

The objectors are concerned that the intended prohibition of waiting at any time (double yellow lines) will reduce the provision of on street parking spaces available to local residents, and cause traffic and safety issues.

Recommendation: Implement the proposals as described in **Appendix 1**.

THE COUNTY OF CARMARTHENSHIRE (AMMANFORD) (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO 14) ORDER 2018

NOTICE is hereby given that the Carmarthenshire County Council propose to make an Order under Sections 1 (1), 2(1) to (3), 4(2), and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended and Traffic Management Act 2004

The effect of the Order will be to amend The County of Carmarthenshire (Ammanford) (Waiting restrictions and Street Parking Places) Consolidation Order 2004 ("The Consolidation Order") (which provides for decriminalised enforcement of contraventions of waiting prohibitions and restrictions) by substituting the plans annexed thereto with the corresponding number plans annex to the order.

The consequence of the proposed amendment will be to:

1. Prohibit waiting at any time in the lengths of road and on the sides of road specified in the Schedule 1 to this Notice.
2. Prohibit waiting and Loading/Unloading at any time in the lengths of road and on the sides of road specified in the Schedule 2 to this Notice.
3. Extend the Prohibition of Waiting in the lengths of road and on the sides of road specified in the Schedule 3 to this Notice.
4. Revoke the Existing Prohibition of Waiting at Any Time to become No Waiting in the lengths of road and on the sides of road specified in the Schedule 4 to this Notice.
5. Introduce 1 Hour Limited Waiting in the lengths of road and on the sides of road specified in the Schedule 5 to this Notice.

and will replace the existing prohibitions and restrictions (if any) that affect the parts of the roads specified in the Schedule to this Notice.

The provisions for the usual exemptions contained in the Consolidation Order will apply in relation to the lengths of road and sides of road referred to in paragraph 1 above. These include the right for passengers to board and alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties, and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to such parts of the roads affected by the proposed restriction.

The Consolidation Order contains the usual parking concessions (where appropriate) for disabled persons in accordance with the Blue Badge Scheme.

Full details of these proposals are contained in the draft Order which, together with the plans annexed thereto showing the lengths of road affected and a statement of the Council's reason for proposing to make the Order, may be inspected at the offices of the Council's Customer Service Centre at The Town Hall, Iscennen Road, Ammanford during the usual office hours.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to The Head of Administration and Law County Hall, Carmarthen. SA31 1JP by the 7th December, 2018.

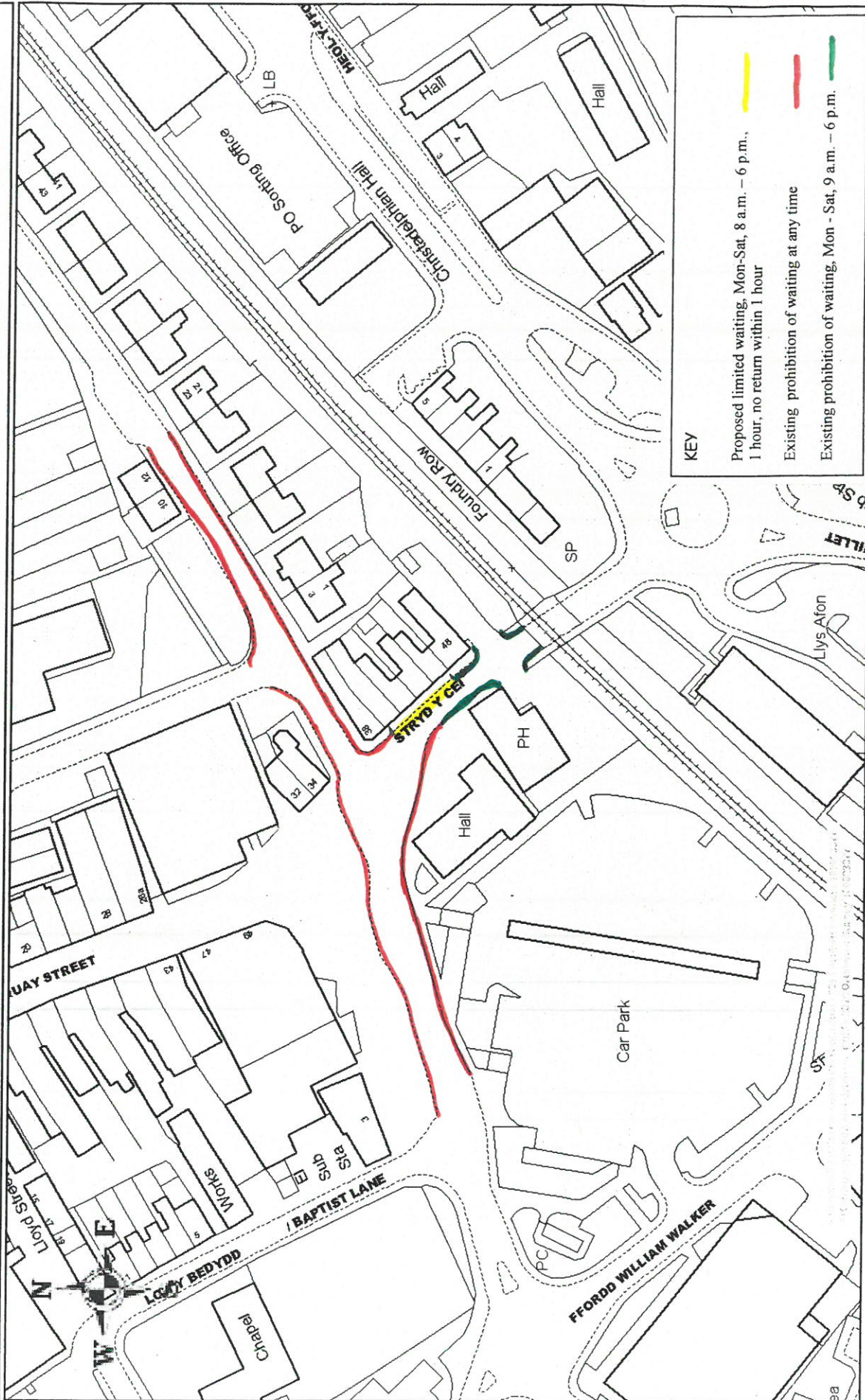

BRIEF SUMMARY OF PURPOSE OF REPORT

1. Purpose

This report is to determine objections received to the proposed on-street waiting restrictions rural order. Full details of the proposed restrictions are listed in **Appendix 1** and **Appendix 2** of the report. The purpose of the proposed restrictions is to safeguard road users and to facilitate the safe and unhindered passage of traffic.

2. Consultation

The advertised proposals are listed in **Appendix 1**.

3. Objections and Comments

During the consultation period the Council's Head of Administration and Law received twenty objections and a 64 name petition against the advertised proposals. These objections are summarised in Appendix 3 along with officer comments and recommendations.

In brief, the objections are explained below:

- i. **Cwmann, A482** - Introduce a prohibition of waiting at any time, on the North side of Treherbert street, near its junction with Cwrt Deri.
The objectors which include a petition of 64 names, request further consultation and refer to previous rejection of the proposals. They say that the proposed double Yellow lines removes natural traffic calming and creates parking issues for residents directly affected, and the wider village. They feel that no parking restrictions at the junction is adequate, as there is enough room to park as the road is not especially narrow.
Recommendation: Implement the proposals as described in Appendix 1.
- ii. **Heol y Gaer, Llanybydder** - Introduce a prohibition of waiting at any time both sides of junction.
The objectors see no reason to place double yellow lines at this junction, which will lead to nowhere for people to park, cause congestion in the summer months when people visit the park and also when football matches take place. The new restrictions will stop people visiting the park.
Recommendation: Amend the advertised proposals as follows:
Prohibition of waiting at any time
Street – Unclassified road U5358, Llanybydder
South side - From a point 40 metres North East of the centre of its junction with Heol Y Gaer for a distance of 68 metres in a South Westerly direction.

- iii. **Trallwm Road/Bryn Isaf, Llwynhendy** – Introduce a prohibition of waiting at any time and loading/unloading at the junction.
The objectors reckon that the proposals will not help with the issue of vehicles stopping to drop off and collect children from outside the nearby schools. They consider the proposals will increase problems of where parents park their vehicles but also just move the issue to the other side of the street.
Recommendation: Implement the proposals as described in Appendix 1.
- iv. **Elkington Park, Burry Port** - Introduce a prohibition of waiting at any time.
The objectors consider that the double yellow lines will have an adverse affect on the street, with vehicles parking and blocking driveways due to displacement and just pushing the parking problems further along the street.
Recommendation: Implement the proposals as described in Appendix 1.
- v. **Danlan Road, Pembrey** - Introduce a revocation of the existing prohibition of waiting at any time and introduce a prohibition of waiting, Monday to Friday between 08:00 and 17:00 hours.
The objector states that he has worked in the area for over 20 years and never had a problem with parking along this road.
Recommendation: Implement the proposals as described in Appendix 1.

The effect of the Order will be to amend The County of Carmarthenshire (County of Carmarthenshire with the Exception of Carmarthen Llanelli and Ammanford) (Waiting restrictions and Street Parking Places) Consolidation Order 2004 ("The Consolidation Order") (which provides for decriminalised enforcement of contraventions of waiting prohibitions and restrictions) by substituting the plans annexed thereto with the corresponding number plans annex to the order.

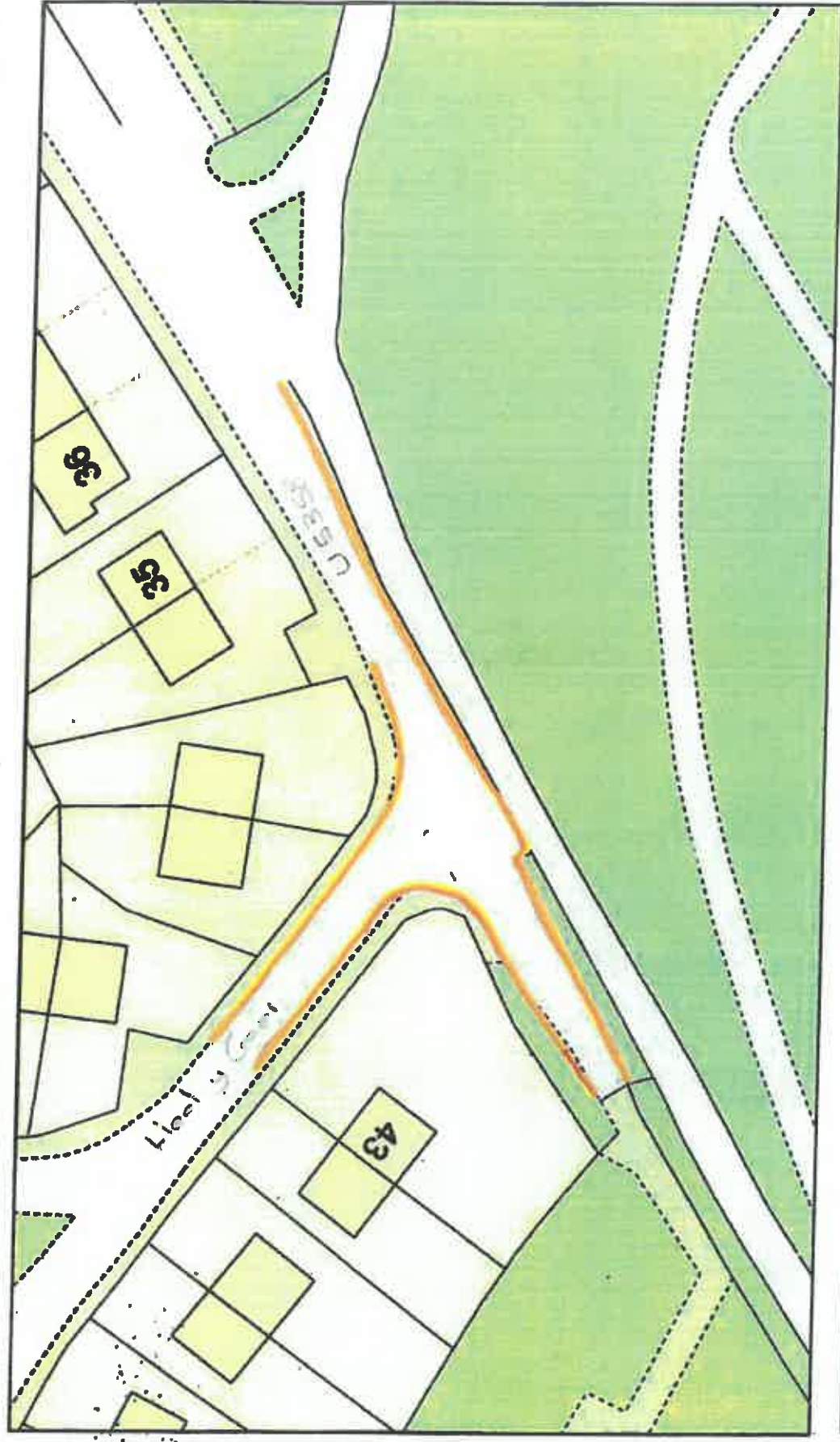

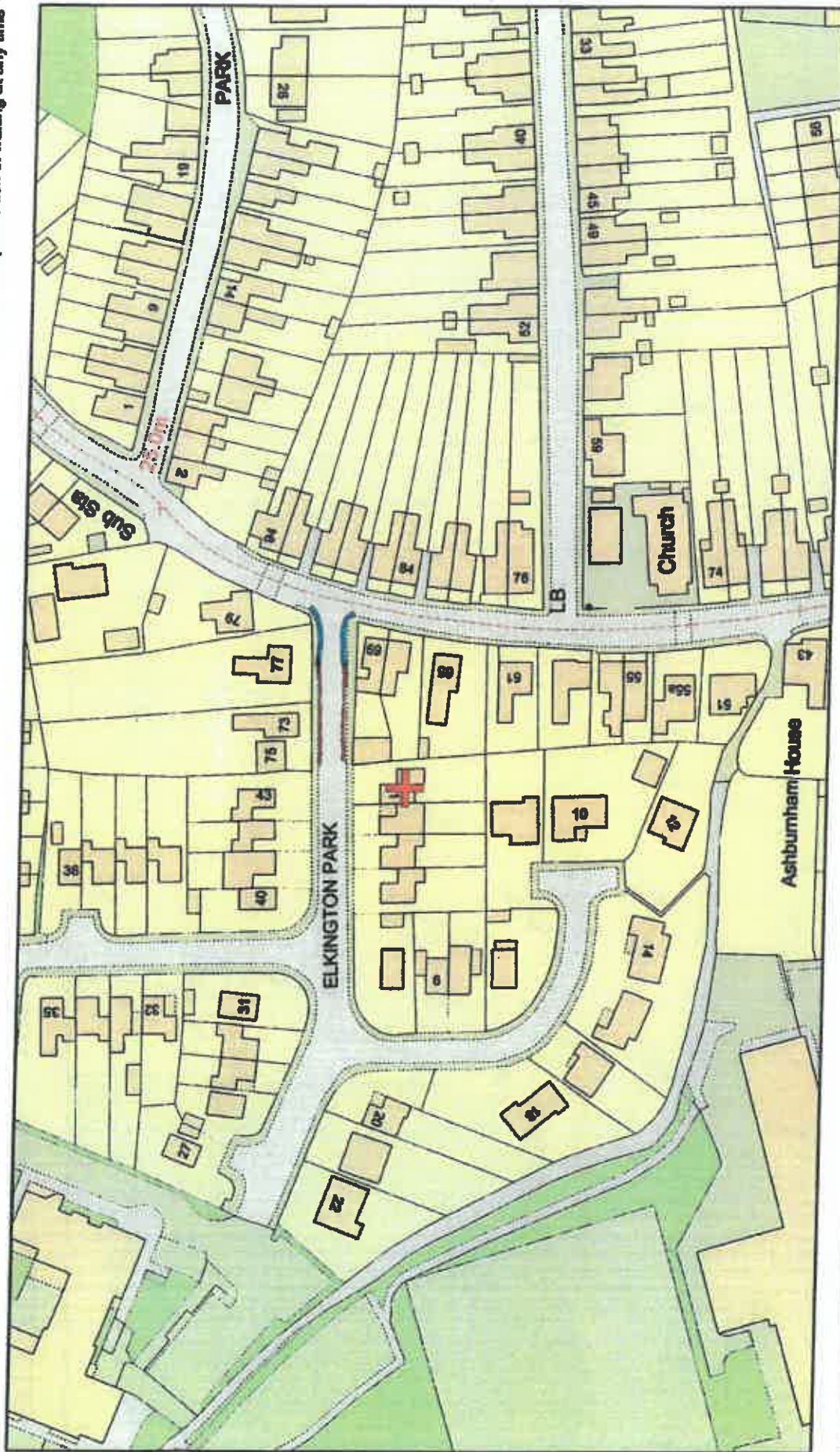

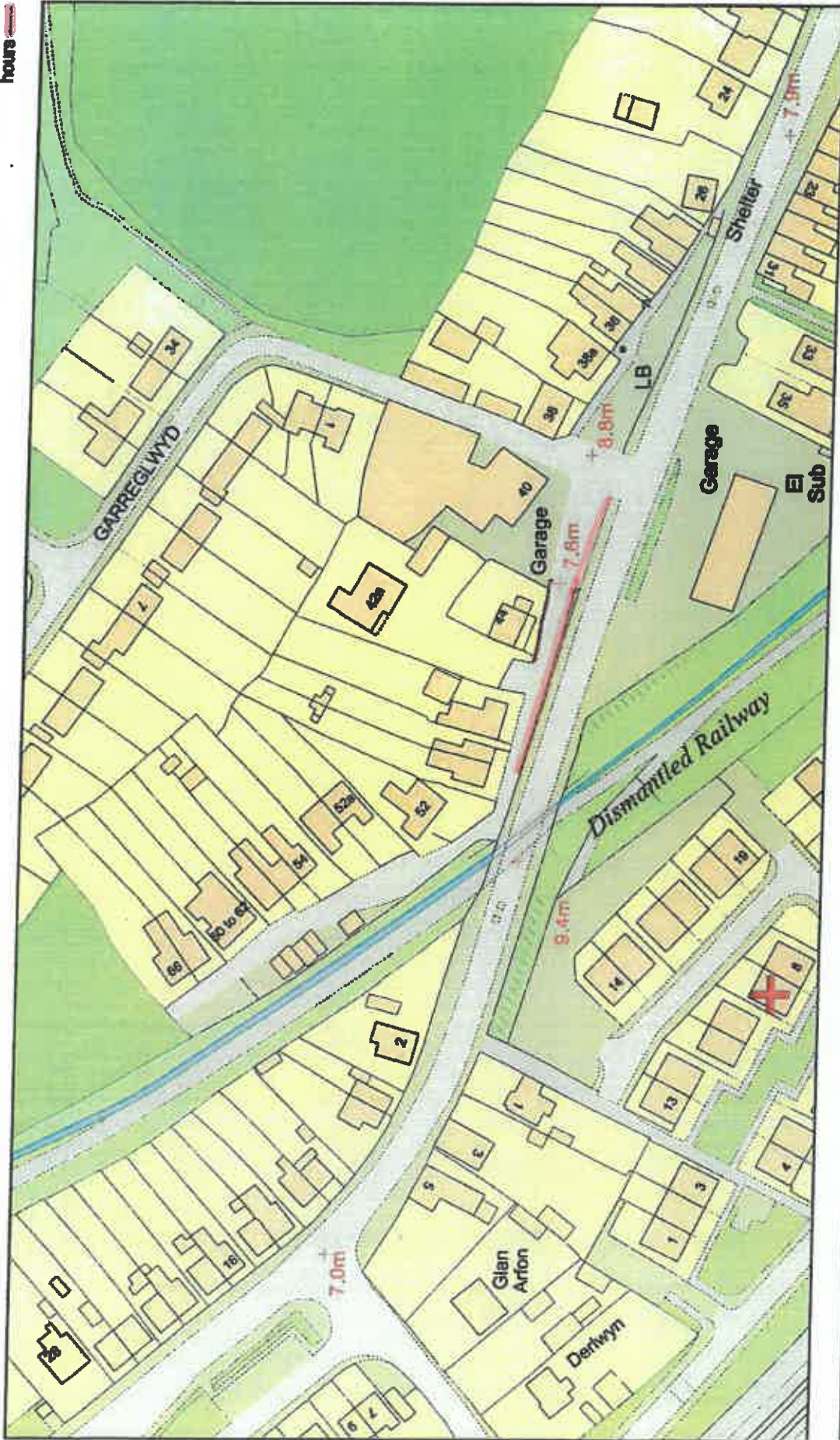

BRIEF SUMMARY OF PURPOSE OF REPORT

1. Purpose

This report is to determine objections received to the on-street experimental order at the following locations within the millennium coastal park:

Objections received to:

- a) Factory Road, Pembrey country park

No objections received to:

- a) Road leading down to car park, adjacent to shoreline caravan park, Pembrey
- b) Access road to festival fields car park, Llanelli
- c) Access road from Burry Port link road to car park

Full details of the proposed restrictions are listed in Appendix 1 and Appendix 2 of the report. The purpose of the proposed restrictions is to aid the free flow of traffic and orderly parking.

2. Consultation

The advertised proposals are listed in Appendix 1.

3. Objections and comments

- 3.1 During the consultation period the Council's Head of Administration and Law received ninety seven objections against the advertised proposals. These objections are summarised in Appendix 3 along with officer comments and recommendations.

- 3.2 In brief, the objections are explained below:

- 3.2.1. **Factory Road, Pembrey country park** - Introduce a prohibition of waiting at any time along Factory Road, Pembrey country park.

- 3.2.1.1. The objectors state that:

There are no arrangements for horse box trailers, which are too big to park in the car park.

There has been no damage to verges/dunes due to parked vehicles and it's wrong to restrict access, which should be free. They also state that they are not willing to pay to park in Fisherman's car park, and that the Authority is making money, as well as preventing encouragement of keeping physically and mentally fit.

3.2.1.2. Recommendation:

Implement the proposals as described in Appendix 1, apart from introducing a parking bay for horse boxes opposite the entrance to the car park near the football field, a length of some 30 metres, to replace the existing double yellow lines. Also, make the experimental order permanent.

Fisherman's car park will remain free, and double yellow lines in this area are not included as part of the order, to be reviewed in twelve months' time.

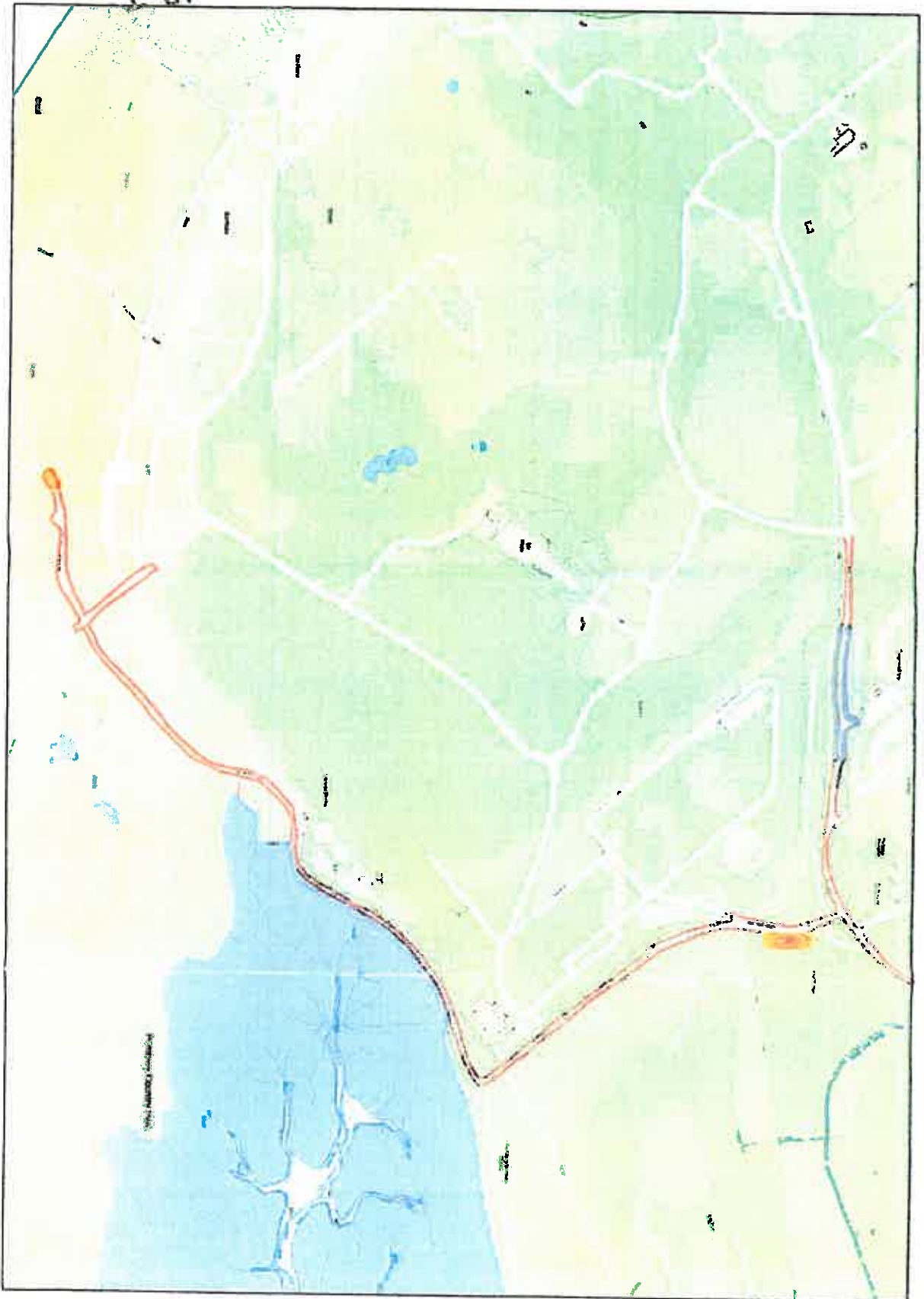

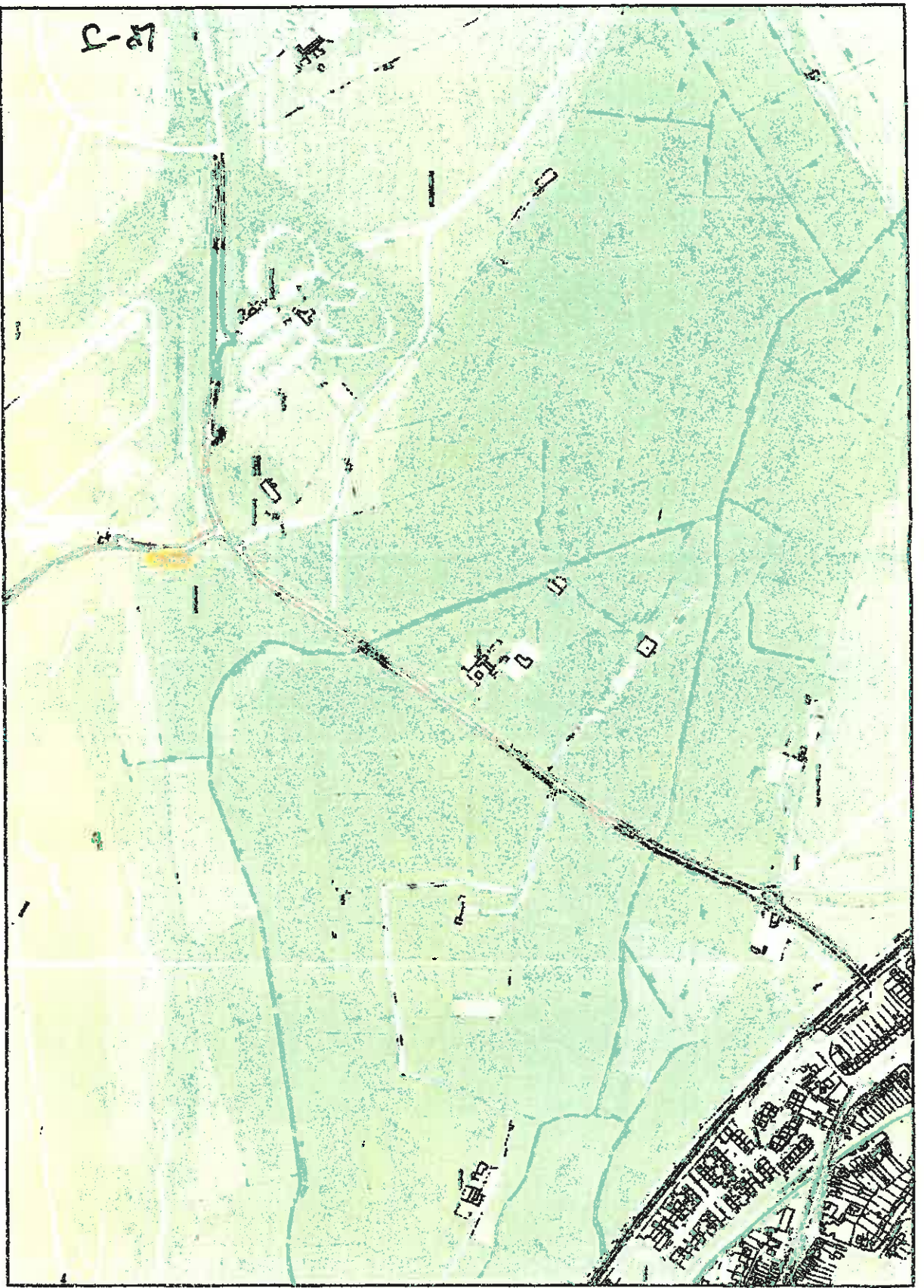

They also state that they are not willing to pay to park in Fisherman's car park, and that the Authority is making money, as well as preventing encouragement of keeping physically and mentally fit.</p>	<p>Response:</p> <p>Traffic Order description: Schedule 1 - Prohibition of waiting at any time Street – Factory Road Both sides – From a point 146 metres North West of the centre of its junction with Waun Sidan for a distance of 1232 metres in a general South Westerly direction. Both sides - From a point 1408 metres South West of the centre of its junction with Waun Sidan for a distance of 120 metres in a Westerly direction. Street - Access road to rear of Pembrey country park. Both sides - From its junction with Factory Road for a distance of 1583 metres in a general Southerly direction.
