Applicant	St Teilo's Church - Llandeilo		
Project Description	St Teilo's Church stands on a site where there has been Christian worship for nearly fifteen centuries, dating back to the mission of St Teilo in the sixth century. A visitor to Llandeilo cannot help noticing the church, which, with its enormous churchyard, is the town's most conspicuous feature. The church building which you see today was completed in 1850; the tower is late medieval, but the churchyard and the site on which the church stands have a much longer history.  At the opening of the present building in 1850, the nave was a vast one, seating some 700 people. In 1979 the north aisle was divided off to create a hall area within the building, together with a kitchen and conveniences, to adapt the building to the needs of the parish.  On the south side of the churchyard, in the wall along Church Street, may be seen an alcove in which a small conduit carries water from a spring in the churchyard itself. This is the outlet from St.Teilo's well which is situated near the eastern end of the church. The well supplied the townsfolk with water for centuries, until covered over in the mid nineteenth century. It is probably a sacred		
	spring, perhaps used as a baptistry from early times.  This project is for the emergency church wall repairs which will be supervised by the Architect who provided the Quinquennial report.  Carmarthenshire County Council has stated that this work has to be carried out as a matter of urgency, temporary netting has been erected to provisionally secure the wall for public safety.

Project Description	Bethlehem is a tiny farming village in the county of Carmarthenshire, Wales, lying in the Tywi Valley Northeast of Llandeilo and Southwest of Llangadog, the chapel is situated a few hundred yards South of the village, which is quiet and scheduled, that is apart from the month of December when thousands of people flock to the village in order to post their Christmas cards and receive the unique Bethlehem Postmark on their letters, even from places as far away, as America and Germany.  The chapel itself, once described as one of the loveliest in Wales, is actually very simple, and seemingly completely unchanged since it was last altered as long ago as 1874. Typically for a rural Welsh chapel, there is no notice board outside advertising the name of the minister and his contact details, or even of the times of the services. It is simply taken for granted that everyone in the area knows. Facing the roadside, steep steps mount up to the schoolroom, beneath which is a door which once led into a stable,

Applicant	St David's Church - Betws
Project Description	St David's Church, Betws, is described as being medieval, possibly 13-15th century, despite extensive renovation in 1872 it still retains about 60% of its medieval core fabric. The church was originally in the parish of Llangyfelach just over the Betws mountain which also included modern day Hendy. The name 'Betws' suggests that there was once a 'bedehouse' in the area, thought to have been a building on the nearby Maes y Betws field. Along with all the other bedehouses in Wales this building has long disappeared. They were all either destroyed or incorporated into present church buildings. A bedehouse was a place of sanctuary, and also associated with almshouses. They had a 'bedesman' in residence whose task was to pray for the founder. The 'bedes' of the name are the rosary beads used in the Catholic Church. Of course, all British churches were once Catholic, until Henry VIII invented a novel way of obtaining a divorce by changing his, and the rest of the country's, religion.
	A recent archaeological study of the structure of the building suggests that the nave and chancel may date back to 1300. The south porch, which is the entrance to the church, was added a little later but might also belong to the 14th century. Elements of the nave and porch roofs are thought to be 17th century and the bellcote has been dated to 1696.
	This project is for refurbishment as recommended by Hook Mason Architects in their report which is to:
	<ul> <li>Carry out repairs and re-pointing to the South West buttress, including the supply and installation of suitable anchoring devices as deemed necessary to secure the buttress to the church building wall.</li> <li>To install a suitable soak away system adjacent to the church building at the South West corner, to adequately remove any rainwater runoff from the roof and gutter. The soak away will be located beneath the tarmac path in line with building regulations.</li> <li>Remove all overhead heaters, isolators and vestry storage heaters. Change all lights to LED units.</li> </ul>
	In undertaking these works, the fabric of the church will be restored to a satisfactory state, ensuring the full use of the building.
