To consider a request from Mrs Carys Ifan on behalf of Canolfan S4C Yr Egin for a recommendation regarding the admission of children to view previously unclassified short films.

The applicant wishes to screen the Discovery Film Festival's Shorts for Wee Ones. This consists of 10 short films.

The applicant also wishes to screen the Discovery Film Festival's Shorts For Middle Ones. This consists of 11 short films.

In order to satisfy the requirements of the Licensing Act 2003, the films shown must have a recommendation concerning the admission of children issued by either the film classification body (BBFC) or relevant licensing authority, which in this case is ourselves.
