Project Description	The hall has several specific aims to ensure a variety of beneficial social activities take place and when the hall was constructed, provision was made for
	further developments intending to increase the scope of general sustainability and community benefits. The design of the hall incorporates sustainability, including social, environmental, and economic aspects and sits sensitively in its environment, with geothermal heating in association with solar panels ensure that its carbon footprint is light.
	They previously applied for funding, to create a multipurpose community area, accessible to children of all ages and abilities, their friends, and families as well as to other local community groups, which has now been completed. This involved an extension to increase the floor space by 61.4 sq. m which allowed for a new meeting room and storage facilities, which has enabled the current meeting room and storage facilities within the hall to be refurbished into a community cafe and social area.
	Over the summer months, with funding provided from Comic relief run a pilot scheme, providing a temporary coffee shop within the hall, which was open Thursday to Sunday from 12.30pm to 4pm. This pilot scheme was to provide a facility for residents to start mixing again, following the COVID pandemic.
	The initiative has proved popular with community members and visitors to the area, the refreshments were provided by the committee members free of charge, tea and coffee provided by the hall committee and the milk is provided by Towy Valley milk who have a vending machine on the hall premises, proven to be a truly community effort.

The community and visitors want them to continue with this provision permanently, expanding on the service provided, as on average they currently have a minimum of 22 visitors every time the coffee shop is open, providing the residents of Capel Dewi, Penrhiwgoch and outlying areas the opportunity to socialise safely.

The funding requested will be to re-establish the current meeting room into a community cafe and to purchase equipment, also staff costs as they move forward from the volunteer stage to creating a job, to run this facility.

Currently they are looking to employ a member of staff for 24 hrs a week, but over time, especially with increased footfall and income, they will be looking at further job opportunities, especially if CCC are successful with future funding for the Tywi Valley Cycle path, as this facility will also become an "Intermediate Hub"

In the Spring and Summer months there will be a need for longer opening hours, which will need additional staff and volunteer time, who will be receiving the necessary skills and training for working in the facility, to include food hygiene certificate.

This new project aims to support the development of sustainable rural communities by improving access to services through the facilities it offers, which are community led, sustainable and of direct benefit to the community.

Building connections with the wider community and engaging with all newcomers to the village, increasing footfall, providing additional income, this in turn will increase the hall's future sustainability and its ability to provide services and activities for future generations.

It is intended that key services will continue as part of the development of the hall as the hub of the community, providing all the necessary services to the future needs of the village.

The opening of a community café will generate additional income in sustaining the delivery of this project.

The hall is the hub of the community and pre-lockdown was used daily for classes, groups, clinics, workshops, and conferences. Classes include yoga, theatre group, Youth Christian Club, Urdd, Ballet, Adult Welsh Folk dancing, flower arranging and a mother and toddler group, really something for everyone within the community. Every weekend was also full of parties, weddings, and concerts. Their outdoor areas are well used daily - the children's play areas, green spaces, picnic areas and as a base to explore the beautiful Tywi Valley and has been an even more treasured space since the covid restrictions came into force.

Project Description/ Community Benefit	The Hangout is a registered charity, with an aim to help adults and children who live in and around Ammanford, who suffer from anxiety, loneliness & behavioural problems, they may be disengaged and talking therapy isn't working. They offer equine programmes for individuals by referral, family groups and their support network and they also have campfire group sessions to make charcoal, whittle wood, weave wool and willow, plus more.
	They have held several successful willow weaving sessions for all ages and would like to grow their own willow to make this activity more cost effective and to give the sessions another dimension by allowing participants to be involved in the growing and coppicing of the willow, which is easy to grow in Wales and can be used for basket making, fuel, living structures and land moisture control etc.
	Currently they are having to buy in willow from commercial providers which increases the cost of each session and limits the variety of willow they use, how they use it and the education around willow, its uses and care. Participants have reported back the therapeutic benefits of working from willow, such as mindfulness, relaxation, increased manual dexterity, a sense of achievement and purposeful occupation.
	The grant requested will be used to prepare an area of ground, purchase weed suppressant matting and willow sticks, along with engaging willow working experts to further educate the staff and volunteers in the skills that they can then pass on at a much-reduced service cost in the future, also allowing them to hold regular sessions to develop skills for those interested in furthering them without the need for payment as many are often not able to do so without causing additional financial hardship.

The funds would also enable them to purchase enough willow to make hurdles that are required for safety reasons as their composting toilet is situated at the edge of the car park, and they would like to create a natural movable barrier that reminds children to slow down as they use the gate to the toilet, so they do not rush through into the car park area. The making of the hurdles would be done by participants, so they remain involved in as many aspects of the charity's development as possible and as an additional skill.

They regularly work with vulnerable children and adults and would like to install CCTV to safeguard participants, staff & volunteers alike. All participants would be informed of the CCTV and its role in safeguarding all against accusations of any description and within the communities that they work with it is not uncommon for accusations to be made, which they have not had any to date. They would also add WIFI extension, so it is available for carers, professionals and participants if needed.

The willow weaving sessions bring communities together to share in a common activity, some of the communities already benefitting are foster and adoption families, youth groups as well as those suffering from mental health issues, providing a safe and understanding environment for those within these communities due to their experience in working within them and their links to Social Services.

The value of shared experiences and side by side learning should not be underestimated, it creates a bond based on something common and shared, dialogue and questioning is created during the activity as well as teamwork to achieve success. As much as possible they hold the activity outside in a sheltered woodland area which also creates an atmosphere of relaxation and tranquillity surrounded by nature which we all know has great mental health benefits.

Skill acquisition for those learning to make hurdles and baskets, could lead to self-employment locally.

Project Description/ Community Benefit	Betws Community Council took over the asset of Maesquarre Playground in 2019. The current equipment is at end of life and there is now an opportunity to improve the area to ensure it is a free facility suitable for all to use and enjoy.	
	As part of the first round of COVID-19 lockdown measures, the UK government stipulated a maximum of one hour's exercise per person per day, images of sunny parks across national press made it clear where people in the UK wanted to spend that hour. Green space is important to us all, and yet millions of people lack good quality green space close to home, especially in poorer areas.	
	Access to nature and better-quality open space is good for us. According to government: "access to natural green spaces for fresh air, exercise and quiet contemplation has benefits for both physical and mental health. Research provides good evidence of reductions in levels of heart disease, obesity and depression where people live close to green spaces."	
	As such, the COVID-19 pandemic provides a new way of looking at the value that residents place on greenspaces. The coronavirus pandemic has therefore resulted in a reshaping of the values that people have for greenspaces, and thereby increase pressure, through social and political actions, for enhancing these environments. Furthermore, given the well-documented health benefits of exposure to natural environments, we emphasise that urban greenspaces are not only useful for providing people with a means for stress release during times of societal disruption, such as a pandemic, but can also help people to prepare for such times physically and mentally. By providing residents areas to exercise and socialise regularly, greenspaces promote physical and psychological well-being, which in turn improves resistance to, as well as the ability to cope with, new pathogens.	
	The project seeks to secure funding for much needed play equipment for children of all ages and accessibility for disabled children, also seating areas for parents and grandparents to meet and supervise the children in the park.	
	During and since the pandemic the need for outdoor recreation and open green space is essential for the community, the funding would provide much needed play equipment for the children, also providing picnic tables and benches for outdoor recreation facilities.	
	The play park and seating area would enable people to meet outside safely to socialize and share experiences of parenting and caring and discuss anxieties.	

The 'Play Sufficiency assessment' identified that playing outside as the most popular setting for children and those parents want a safe environment for children to play. Their main worry and concern were the increase in road traffic.

Lots of families travel to other areas to use their facilities which have a more varied function than what is currently available on the site/within the village. A better range of facilities would ensure less travel and help with the village's carbon footprint reduction, improve, and help to maintain the close-knit village feel/culture.

# Evidence of Need / Community Engagement

#### Questionnaire

A questionnaire was distributed to all dwellings within Betws Ward during Summer 2020. The purpose of this exercise was to gain understanding of what the residents of Betws wanted to happen to all 3 parks / play areas within the ward and to provide all with an opportunity to have their say regarding the area.

#### Seating Area / Picnic Tables

A respondent stated, 'Benches put back for parents to sit while kids playing would be good', while another wrote 'maybe seating for the oldies or one or two picnic tables?'. This is a common theme within the responses with 21% of the respondents stating that benches and/or picnic tables would be ideal improvements to Maesquarre Playground.

#### **Toddler Area**

22% of the respondents said that the park does not currently have adequate play equipment for toddlers, with one respondent stating, 'there is nothing for small children', whilst another stated 'area for 1–3-year-olds please'.

Further evidence of needs has been provided by the community, via emails, telephone calls and social media, also written letters of support have been provided.

#### Summary

The Community Council have consulted with all within Betws Ward via the questionnaire and been contacted by several local individuals regarding Maesquarre Playground.

From the questionnaire results and speaking to locals who use the playground, the Community Council were able to understand the needs of the Community and priorities the above 3 points. Also, a meeting with the maintenance company was arranged to find out which current equipment needed to be replaced / taken out first.

## Contributing to the themes of the Fund

#### **Health and Recreation**

As outlined in CCC's Well Being Objectives child obesity is on the increase in Carmarthenshire and is above the Welsh average, it is important therefore that children have every opportunity to be active and play outside. Play is an important part of a child's development, and the improvement of the play facilities will promote the health and well-being of the residents of the village of Betws and adjacent areas.

#### **Environment**

The project will improve the physical environment of the area as the current facilities have become tired and not fit for purpose, providing a more attractive and welcoming park will encourage increased participation and will help foster a sense of ownership and pride amongst residents. The materials specified for the works will where possible be from sustainable sources and local contractors will be used to reduce the carbon footprint. The equipment will be capable of being recycled at the end of its life.

#### **Education**

It is proven that children learn through play, it helps to improve their gross and fine motor skills, develop social skills by sharing and taking turns. Playing together will encourage children from different schools to integrate and form friendships, and therefore welcoming new children into the community. Playgrounds provide crucial and vital opportunities for children to develop cognitive and physical skills through play. Playgrounds that promote different types of play are vital for a child's cognitive, emotional, physical, and social development.

#### **Energy Efficiency/Sustainability**

The provision of the additional equipment will ensure the sustainability of the play area as a main playground provision in the community. The Council regularly checks the equipment and ensures repairs are swiftly completed to ensure the longevity of play equipment

	This project is to make the hall building completely energy efficient by installing solar panels, part of the committee's energy conservation plan, having already changed the lighting to LED, replaced all windows, their future proposal was to generate their own electricity with solar panels, reducing energy costs making the organisation more sustainable.	
	The reduction in heat loss, reduced energy usage, lead to reduced costs and these reductions are fed back to the community groups through minimum hire charges, thus making the hall affordable to all.

Project Description	During the current pandemic the Centre has been running a Help Llandovery Facebook page and enlisted over 70 volunteers to deliver groceries, prescriptions, post mail, etc. They have also been running a much-needed foodbank which has help to support many families in need. This has meant we have a greater understanding of the needs of the local community and this project would aim to meet some of those needs in respect of food poverty.
	A demonstration of the food poverty situation in Llandovery is that over the last 12 months the foodbank at the LYCC has supported an average of 98 people each week. The Centre also acts as a receiving point for people to collect their purchases of food boxes at reduced prices from the CBSA.  The Community Centre has a garden area to the rear of the building with a workshop and beehive. Volunteers tend the garden, but the group would like to run specific courses for vegetable gardening/cookery for members of the
	local community. They have included dual-fruit trees in this application so that people can see how it is possible to produce fruit in very small spaces.  The garden area includes a beehive which is excellent for making people aware of the importance of bees. A camera to be placed next to the beehive to record their activity would further develop the work they are doing in this respect. Some additional bee suits would enable participants on the course to experience the beehives close.
	The group would like to run 12 x 4-hour sessions to encourage additional people other than those who attend the Centre to join in gardening and cookery sessions, utilising vegetables/fruit grown in the LYCC garden promoted via their foodbank.  In addition, they run a Getaway After School Club for children aged 9+ and Youth Club for young people aged 11+. They would use the extra equipment with them to encourage them to be involved with growing edibles and

	cooking them afterwards and thereby influencing their families. The group work with 95 children and young people in the Centre.
	The addition of a greenhouse would make it possible to plant seeds in the autumn and then plant out in the spring. It could also be used to over-winter plants. It would be an excellent resource to encourage people to see gardening as an all-year round activity.
