**Background Information**

The Local Authority is responsible for promoting high educational standards and for delivering efficient primary and secondary education across the county. Having effective leaders in its schools is considered central to this and is a challenge facing councils across Wales.

The federation of schools is a legal process which enables schools (between two and six) to work together through a formal structured process by sharing a governing body that will make decisions in the best interest of all the schools, staff and pupils in that federation.

As Ysgol Gynradd Llangain, Ysgol Gynradd Llansteffan and Ysgol Gynradd Bancyfelin Schools share the same Headteacher and each schools' governing bodies have worked collaboratively over the last few years which is continuing to impact positively upon the schools, the Local Authority now intend to propose a formal federation between the three schools. Whilst each school will continue to have their own individual identity with regards to name, culture, ethos and continue to manage their own budgets, this process involves establishing a single governing body to govern the three schools.

As such the consultation document (link provided) sets out the case for a formal change to the leadership and governance arrangements at the schools.

**The Proposal**

The proposal is to establish a formal federation between Ysgol Gynradd Llangain, Ysgol Gynradd Llansteffan and Ysgol Gynradd Bancyfelin.

A formal consultation exercise was undertaken from 22 February 2021 to 4 April 2021. The results of the consultation exercise are contained in the attached Consultation Report.

If approved, the proposal will be implemented on 1 September 2021.

**Recommendation**

It is recommended that the Executive Board Member approves the implementation of the proposal to formally federate Ysgol Gynradd Llangain, Ysgol Gynradd Llansteffan and Ysgol Gynradd Bancyfelin.

# 1. Executive Summary

## The Consultation Period

On the 22<sup>nd</sup> February 2021 Carmarthenshire County Council published proposals to:

- Federate Ysgol Gynradd Llangain, Ysgol Gynradd Llansteffan and Ysgol Gynradd Bancyfelin from 1<sup>st</sup> September 2021.

The consultation period commenced on 22<sup>nd</sup> February 2021 in line with the publication of the proposal and closed on 4<sup>th</sup> April 2021 with a total of 8 responses received (excluding the responses received from the pupils' consultation) in response to the formal consultation.

It must be noted that of the 8 observations received, all were received prior to the end of the consultation period.

## Consultation Event

Due to the ongoing implications of the Coronavirus issue we were advised to postpone all events where there was interaction between staff, parents and the wider community and as a result virtual drop-in sessions were held via Microsoft Teams.

Formal drop in sessions were held virtually on **15<sup>th</sup> and 16<sup>th</sup> March 2021 for Governors, Staff and the Public**. The formal consultation drop in sessions were attended by 21 stakeholders in total.

## Responses Received

This proposal has been prepared in line with Welsh Government's "Federation Process of Maintained Schools in Wales for Governing Bodies and Local Education Authorities" guidelines and hopes to strengthen the already successful relationship between the three schools.

However, it is not possible to combine teacher and staff governor categories, and there is also no allowance to have 3 teachers and/or 3 staff governors on the new GB, even if the other categories were reduced.	1	13%

2.	<b>Model of Provision</b> Respondents asked for clarity on the reasons for federation and how federation would impact on staffing and school budgets.	By entering into a federation, the three schools can work together under shared leadership to utilise their strengths to improve standards across the federation and together address areas in need of improvement. By federating under one governing body, the climate of trust, openness and willingness to work together that already exists can be enhanced.  The way in which an individual school's budget is calculated is not affected by federation – each school in the federation should continue to receive its own budget based on the number of registered pupils at the school plus any other factors. However, schools will be able to pool or share their budgets.	1	13%
