<b>Project Description</b>	<p>The Bywyd Bywiog is an innovative project which strengthens on previous experiences in this field and will provide a new extended composite approach to teaching pre-school and children 0 – 7 years of age and their parents/carers, which includes numeracy literacy and parenting skills, exercise and diet.</p> <p>To provide this continued and additional service <b>MCGE will need to appoint an additional project officer</b> who will engage with community groups and partner organisations within the health and wellbeing sector in Cwm Gwendraeth and Llanelli areas including schools, nursery groups, family centres, health visitors, GP surgeries and private nurseries in order to address integration, access and community cohesion for vulnerable groups.</p> <p>The extended age category and new 12 week sessions have been developed following feedback from parents and teachers and sits well with the Foundation Phase work undertaken in schools. Training sessions will enable individuals to learn a variety of social skills and techniques.</p> <p>This approach will strengthen engagement with people at grass roots to improve numeracy, literacy and the adoption of a healthy lifestyle. The project will encourage adults to take personal responsibility and recognise the importance of healthy lifestyles and the importance of strengthening family relationships.</p>

	<p>is able to project their voice to the back of the hall.</p> <p>If the choir have guest soloists they sometimes require amplification and many venues are unable to provide this or charge us to hire. The choir provides fun events for members and others when organising fundraising activities, which include quiz nights, karaoke night and craft sales.</p> <p>Research into singing has shown it is good for your <b>Health</b> and particularly for your heart and general well being. Professor Graham Welch, Chair of Music Education at the Institute of Education, University of London, has studied developmental and medical aspects of singing for 30 years and he says the health benefits of singing are both physical and psychological. He says "Singing has physical benefits because it is an aerobic activity that increases oxygenation in the blood stream and exercises major muscle groups in the upper body, even when sitting.
