SUBJECT:

PRIVATE HIRE VEHICLE LICENCE

To consider an application from Mr Meirion Williams of Dusk Till Dawn Limousine Hire, Caerodyn, Pantllyn, Llandybie, Carmarthenshire to be granted an exemption from Condition 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles for his Chrysler 300C registration number L11 GAD.

Mr Williams has requested that as he intends to operate this vehicle for Air & Sea Port travel, School Proms and Executive Hire only, that he be granted an exemption from Condition 5a and 5b of the Council's Licence Conditions, namely that he be not required to display door stickers and a licence plate on the rear bumper of his Vehicle.

Should the Licensing Committee agree to grant Mr Williams an exemption from condition 5a and 5b of the Council's Licence Conditions for Private Hire vehicles, then the following Licence Conditions be attached to the Licence:-

That the licensed Chrysler 300C registration L11 GAD be exempt from licence conditions 5a and 5b, whilst being used for Air & Sea Port travel, School Proms and Executive Hire purposes as outlined in the application by Mr Williams.

That should the vehicle be used for Private Hire other than Air & Sea Port travel, School Proms and Executive Hire, then the applicant shall immediately notify the Licensing Authority and the exemption shall cease in relation to such hiring.

That the vehicle displays an identification disc on the front and rear windscreens, as specified by the Licensing Authority.

SUBJECT:

HACKNEY CARRIAGE VEHICLE LICENCE

To consider an application from Mr Andrew Paul Morgans of AJ's Taxis, 38 Park View, Llanelli to be granted an exemption from Condition 15(e) of the Council's Conditions of Licence for Hackney Carriage Vehicles. This condition states that the engine capacity of the vehicle shall not be less than 1200cc.

Mr Morgans has requested that he be granted this exemption from Condition 15(e) of the Council's Conditions of Licence for a Nissan Leaf Electric Car Registration Number YC16 WGF. This vehicle features an advanced 30kWh rechargeable lithium-ion battery pack designed to provide clean, reliable power and therefore does not meet the current Engine Capacity Licence Condition.

This vehicle is fully compliant with all other Conditions of Licence for Hackney Carriage Vehicles.

Mr Morgans was previously Granted this exemption by Committee on the 1st December 2016 for another Nissan Leaf Electric Car, Hackney Carriage HC747.

APPOINTMENT OF LICENSING SUB-COMMITTEES

Council, at its meeting held on the 6th January, 2005, gave consideration to the arrangements to be made to ensure the efficient discharge of its duties under the provisions of the Licensing Act 2003. As part of those considerations, it resolved to amend the constitution Part 3 Table 3 (Responsibility for Functions)(Licensing Committee) under the heading "Membership" to add the following words:-

"To act when so required by the provisions of the Licensing Act 2003 through Sub-Committees consisting of three members."

In view of the Council's decision, the Committee will now need to formally appoint its Sub-Committees in readiness for the determination of applications received under the Act. The Committee previously considered the issue of the establishment of Sub-Committees and felt that the optimum solution would be to establish three Sub-Committees, politically balanced, comprising five members each, with the membership of a Sub-Committee on any given day being drawn from those five members on a rotational basis (subject to the procedures for the appointment of substitute members as provided for within Council Procedure Rules 4(9) and 4(10).

However, at the Council meeting held on 24th May, 2017 the composition of the Licensing Committee was reduced to 14 members and the Committee therefore needs to consider whether to establish two Sub-Committees comprising 5 members and 1 Sub-Committee comprising 4 members or alternatively to establish 2 Sub-Committees comprising 7 members each, as politically balanced as possible.

Suggested membership of each Sub-Committee for both scenarios is detailed below. The appointment of Chairs for each Sub-Committee will be considered under the next item on the agenda.
