<b>Project Description</b>	<p>The concept for Angor started over 15 years ago when it became apparent that there is a real need for a support service in Carmarthenshire for individuals who have been diagnosed with cancer or a life-altering diagnosis.</p> <p>Angor will offer practical, financial, legal, social, and emotional support to people who have been diagnosed with cancer or a life-limiting illness. Angor will practice in an environment that is welcoming, informal and non-institutional, enabling participants to connect with others to form new support networks. Angor will meet and signpost individuals and discuss the support available, as well as providing educational opportunities which encourage all participants to be proactive in their recovery and their future objectives.</p> <p>Funding is required to recruit a self-employed individual with a proven track record in several key areas i.e., community development, project management, community consultation, marketing and fundraising.</p> <p>Angor wishes to employ an individual for 25 hours per week over the next 12 months to support the Trustees in coordinating key elements of the project including:</p> <ul style="list-style-type: none"> <li>• Developing Angor's business model</li> </ul>

Angor aims to facilitate 'wellness' providing a pathway from a clinical setting, through to and back to the community.</p>

<p><b>Evidence of Need / Community Engagement</b></p>	<p>People who have been diagnosed with cancer or a life-limiting illness mention the gap that exists between the diagnosis and the support needed to move on with life.</p> <p>Angor believes:</p> <ul style="list-style-type: none"> <li>• The impact of cancer or a life-limiting illness is not just physical, a holistic approach is needed for recovery</li> <li>• Recovery is assisted by attending to the needs of the whole person, mind, body, spirit and emotions</li> <li>• Emotional &amp; practical support should be freely available to people who have been diagnosed with cancer or a life-limiting disease</li> </ul> <p><b>What is different about Angor?</b></p> <p>No other organisation in Carmarthenshire currently provides this signposting bespoke user-led holistic wellbeing service where the emphasis is on empowering the user to become proactive in their rehabilitation through education and support. There is a clear gap in provision which they intend to address. They will work with established organisations to signpost and support.</p> <p>The need for support for people with cancer or a life limiting illness has never been greater. According to figures published by Macmillan, there are over 160,000 people living with cancer in Wales alone. As treatments have improved, cancer is now often for many a “chronic condition”. A Welsh Government survey in 2020 found that 35% of adults stated that they were living with a life-limiting illness.</p> <p>Once established, individuals will be able to access their new centre during office hours for advice and a chance to sign-up to a programme of support. Various activities offered will include mindfulness, cancer massage, reflexology, art therapy, relaxation classes, wig and hair advice, these will be developed as the programmes evolve. Other services such as financial, legal and probate advice will also be available. These examples are not exhaustive, and wherever possible Angor will aim to respond flexibly to the range of needs, as and when they arise. The plan is that Angor will evolve and adapt to the identified needs of the client.</p> <p>Recently released figures from Public Health Wales identify an increasing number of people living with chronic liver, cardiovascular, and neurological diseases, especially in Carmarthenshire. If the number of people diagnosed with a life-limiting illness is added to the cohort of people living with cancer, the need for a service such as Angor is evident.</p> <p>The Trustees have engaged with Maggie's in Swansea, they fully recognise the need for Angor's services to the west of their operation. There is no duplication. Patients and their families deserve key support services on their doorstep.</p>

	<p>In March 2022, Angor conducted a survey of stakeholders in Carmarthenshire for their views on support following a cancer or life-limiting illness diagnosis. Surveys were distributed across the county and made available at numerous Doctors Surgeries and Pharmacies.</p> <p>Geographical areas included Ammanford, Burry Port, Carmarthen, Crosshands, Garnant, Glanamman, Kidwelly, Laugharne, Llandeilo, Llandovery, Llanelli, Llanybydder, Pontyberem, Newcastle Emlyn, St Clears, Tumble, Trimsaran and Whitland.</p> <p>Respondents felt that a service such as Angor was needed. Responses mentioned “a need for support”, “holistic therapy”, “networking with others”, “Guidance”. Angor will aim to meet these needs.</p>

There are currently over 2 million people living with cancer in the UK, with recent statistics revealing that 350,000 people are diagnosed each year.</p> <p>Angor has strong governance and is fully aware of the legal, supervisory and moral responsibilities arising from trusteeship. Many of the Trustees are true community ambassadors and leaders who have fostered relationships across the private, public and third sector over several years.</p> <p>The self-employed role is fixed term but will allow them to shape their key services and become sustainable. They will naturally increase the number of paid staff over time as the enterprise becomes more established and develops.</p> <p>Key tasks delivered over the next 12 months will no doubt place Angor on a better footing namely:</p>

<b>Project Description</b>	<p>Tregib Sports Facilities is a community managed, not for profit organisation managing the sports facilities on the Tregib School site Llandeilo Carmarthenshire since 2016. These facilities include an Astro turf, three football pitches, two rugby pitches, a running track, sports hall, gymnasium and changing facilities. The company is managed with the 20 clubs and organisations engaging around 1,000 community volunteers and participants of all ages in a wide range of sport and other physical activities.</p> <p>Recent Pitch Assessments of the Astro turf surface state it is at end of life and needs replacing by Summer 2023, risking the Astro turf being lost to the community. The groups have developed a strategy to work together, with local businesses, sports associations, and Carmarthenshire Council to raise finances to replace the Astro surface with a new Hockey Turf Pitch, with a 15-year life span, suitable for Football, Rugby, and Hockey and to install new energy efficient LED floodlights.</p> <p>The Astro Turf creates much of the income for the facility which then subsidises the rest of the facilities. As a result, all the other groups/users have the benefit of sustainable prices and the use of the Sports Hall, Gym, Changing room facilities etc. Thus, their fundraising campaign is entitled 'Save Tregib Sports</p>

facilities' as without a functioning Astro pitch the community run sports complex is not sustainable.

They will use this grant funding together with the other funds to replace the Astro surface, install new energy efficient LED floodlights and will also appoint a specialist Project Management consultant to oversee the project and all quotes have been obtained.

Since they took over the management of the facilities in 2016, ensuring the facilities are affordable has been one of their main goals, they have not increased the prices since they have been running the facility, and after re-opened after Covid, they used the Covid Support Funds given to initially open the sessions free of charge, and then reduced their prices by 50% over 6 months and then by 25% to ensure all the users were able to come back and that finance was not a barrier to their sporting activities.

Having a new Astro Turf will allow them to continue operating in this manner as approximately 50% of the income comes from the Astro Turf bookings. Having new LED floodlights will also help with economic stability as their energy demands will fall by at least 40%, an essential element, faced with increasing energy costs.

Without refurbishment the surface will not be safe to use after summer 2023. It is currently used by up to 670 players per week, users are representatives of the local community in terms of age and gender.

The clubs using the Astro offer exercise and social contact to players who risk exclusion and declining wellbeing, including recent refugees, individuals recovering from significant illness, anxiety, and depression, they are also supporting players to stay active in sport into their late 60's.

Half of clubs and groups have male and female participants who are regularly active. The Astroturf offers exercise and social connections to individuals who risk exclusion or declining wellbeing:

There is an Astro Turf pitch at the local secondary school - Ysgol Bro Dinefwr but at present this facility is not available for community hire or use. It is also not a floodlit pitch which would limit its effectiveness. The nearest floodlit Astro Turf pitch is in Ammanford 8 miles away, if their users were to travel there would obviously be travel time and cost for all the participants. Also, there is a capacity issue as the Astro Turf in Ammanford is remarkably busy, with only a few slots available on a Monday and Friday evening. They are planning to undergo their own resurfacing exercise in October 2022, so the new surface is likely to attract more users who are local to them.

However, in a survey conducted in December 2021, 8 of the groups using the Astro reported that their 631 members would not regularly travel to less local facilities if the Tregib Astro were no longer available. The increases in costs of petrol during and the cost-of-living crisis mean that both Llandeilo adult and child players are now less likely to travel to other more distant facilities.

Without a safe and functioning Astro Turf pitch, the community run Tregib Sports Facilities is unsustainable. The Sports Hall, Gymnasium users, running track users and football and rugby pitch users may be unable to pursue their sporting activities.

Eight of the groups using the Astro report they would not be able to organise activities for their existing 631 members using alternative facilities.

What would it mean to you if the Astro Turf were not available for you to use?

- A lot as it is an exceptionally reliable place and area to play and teach sports.
- Being a very sporty person, I would think it would have an excessively substantial reduction in my sport participation level.
- I would be sad because I like playing with my football team
- I would be sad because I like to go to Tregib after school in school clubs

They also undertook a survey of the groups that use the Astro in Dec/January 2022 and have an online survey that they have promoted online and through their Facebook page

The Crowdfunding campaign was started over the summer holiday and despite most of their users being on holiday, they have already raised over £5,300 through 74 individual supporters even though the focus of their Crowdfunding is to take place during September.

To do this, an overhaul and upgrade to the stage lighting system needs to take place.</p> <p>Adaptations and upgrades need to be put in place to secure the usability and longevity of this vital facility in the future. Most of this maintenance can be done by in house team members who are technically trained. The motors and winches for lowering and raising the on-stage lighting bars will be inspected annually by a qualified company.</p>
