POVERTY FUND UPDATE

BRIEF SUMMARY OF PURPOSE OF REPORT

As approved by Cabinet Member on the 27th October 2022, the Authority is administering a Third-party grant entitled the Poverty Fund which is open to any constituted organisation which is seeking to support those that are facing poverty in Carmarthenshire. Grants of between £1,000 and £10,000 will be made available.

Cabinet Member approved a total budget of £180,481 to support projects which is being made available via various Welsh Government funding sources.

The fund will be administered by the CCC central Bureau team via a Third-party grant process.

Since the report was considered and approved by Cabinet member, we have subsequently received an additional £50,000 from the Welsh Government's Discretionary Fund and an additional £57,174 via Welsh Government's Direct Food Support scheme. With this additional funding, we propose to increase the overall budget available for the Poverty Fund from £180,481 to £287,655.

As per the original approval, all applications will be assessed by the Bureau funding panel and that delegated authority is given to the Head of Regeneration to approve all applications up to the maximum £10k.

Regular updates will be providing to Cabinet Member on progress.

Activities supported via the fund will be promoted via the Authority's website as well as via our third sector networks and Town and Community Councils.

Finance

The support is fully funded, provided by WLGA and Welsh Government.

Balance available for 22/23 financial year £48,236 (Cap £21,295 and Revenue £26,941) plus an additional £50,000 from WG Discretionary grant as well as £27,120 from Welsh Government's Direct Food Support scheme, £55,125 from Welsh Government's Warm Hubs initiative, £50,000 Discretionary fund (Rural) and £57,174 top up from Welsh Government's Direct Food Support Scheme bringing the total budget to £287,655.

HOUSEHOLD SUPPORT FUND

1. BRIEF SUMMARY OF PURPOSE OF REPORT.

The Authority has received funding via the Welsh Government Household Support to support people facing food poverty.

The Authority was initially allocated £27,865 in January 2022 of which we allocated £19,838 to foodbanks as approved by Cabinet Member on the 26/01/2022.

Subsequently we received an additional budget of £55,729 in April 2022 to be utilised during the financial year 22/23 of which £22,600 has been allocated to local foodbanks. Balance of funds available £41,156. In addition, Cabinet approved on the 3rd October an additional budget of £50,000 via Welsh Government's Discretionary Cost of living Scheme to enhance the household support fund.

In total, there is an available budget of £91,156. It was agreed by Cabinet Member on the 27th October that the Household Support Fund would be made available to local foodbanks that are helping to tackle food poverty within the county. Support would be made available for the purchase of additional supplies of good quality food and essential goods via Castell Howell Foods by the Council on behalf of the foodbanks.

In order to identify demand, foodbanks were contacted in October 2022 and invited to submit an application, setting out support required over a four-month period from the middle of November 2022 until the middle of March 2023. In total, the following 16 Foodbanks were contacted and invited to submit applications for funding:

- Salvation Army
- Xcel Foodbank
- Llandysul Foodbank
- Newcastle Emlyn Foodbank
- Tyisha Foodbank
- CETMA
- Antioch Centre
- Llwynhendy Foodbank
- Myrtle House Foodbank
- Ammanford Foodbank
- Cwmamman Pantry

- Llandeilo Foodbank (Bocs Bwyd)
- Llandovery Foodbank
- Whitland Foodbank
- Trimsaran Foodbank
- Llannon/Tumble Foodbank

1 new foodbank contacted us directly. Subsequently, we received applications for financial support from 8 foodbanks.

The applications received were assessed by the Bureau’s grants panel, taking into consideration the number of people that they are currently supporting, future numbers, along with how they plan to target the most in need. When assessing we considered each application based on the monetary value requested, divided by the numbers of individuals supported over a four month period, subsequently this exercise identified an average cost per head that was used as a comparison when determining the maximum grant awarded. These ranged from £3.50 per head to £10 per head which is due to varying reasons such as access to donations and support from other sources. Given that support is required swiftly, we have relied on the detail provided by the foodbank in terms of numbers of people accessing the foodbank and the level of resource that they need to support existing demand. The Authority will enter into an agreement with the respective foodbanks which we shall be monitoring.

Based on the assessment undertaken, it is recommended that funding is awarded to the following foodbanks to the value of £65,300 (total amount) in respect of **8 individual applications**:

- 1) Cwmamman Pantry £7,000
- 2) Myrtle House £15,000
- 3) Christ Church £4,000
- 4) Antioch Christian Centre £2,800
- 5) Llwynhendy Foodbank £15,000
- 6) Tyisha Foodbank £12,000
- 7) Llannon/Tumble Foodbank £6,000
- 8) CETMA £3,500

If the aforementioned applications are approved, a total of £25,856 remains uncommitted. As agreed by Cabinet Member on the 27th October, it is proposed that this amount is vired into the County’s wider Poverty Fund.

2. OTHER OPTIONS AVAILABLE AND THEIR PROS AND CONS

There are no other options. The funding has been allocated to Carmarthenshire to support an increased number of people facing food poverty.
