# EXECUTIVE SUMMARY CABINET MEMBER DECISIONS MEETING FOR REGNERATION, LEISURE, CULTURE AND TOURISM DATE 12.02.2024

#### Ten Towns Programme (Capital Fund)

#### Purpose:

To consider an application submitted as part of the Ten Towns capital fund.

#### **Background**

The aim of the Ten Towns Programme is to increase the resilience and future growth of Carmarthenshire's rural market towns and their surrounding areas.

The Authority has committed £1m capital funding to support the respective towns to take forward some of the capital aspirations identified within their economic growth plans. To ensure that the ambitions of each town are realised, and that prioritised projects are developed, Carmarthenshire County Council have secured further funding from the UK Government's Shared Prosperity Fund.

#### Application for consideration:

**Applicant:** St Clears Town Council

Title: Y Gat and St Clears Gateway project, St Clears

Grant Requested: £33,697

The application for funding by St Clears Town Council focuses on two projects which have been identified by the town's economic growth plan team to support the development of the town:

#### Redevelopment of Y Gat

Recognised as an anchor building for the town, Y Gat has recently been transferred from the Authority to the Town Council. Following several engagement exercises with stakeholders, established groups and local business, St Clears Town Council is seeking funding to undertake modest reconfiguration works to the building to create a multipurpose space for both business and community use which will include:

- A designated shared working space on the second floor for local businesses. The space will
  also be used to hold community workshops e.g. digital classes. The library service will
  continue to operate from the premises as well as meeting rooms being available for hire for
  both business and community use.
- The reconfiguration work will enable a separate access to the café area which is currently being advertised as a business let
- The third floor will remain a space for local micro businesses to rent. The focus will be on the creative industries to tie in with the previous use of the building. The administration of the lettings will be undertaken by a local estate agent. There have been an encouraging number of enquires for the units available.

To support activity and encourage visitors to the town, the Town Council has appointed a centre co-ordinator whose primary role will be to facilitate events and administer bookings for Y Gat.



As the redevelopment of the building begins, a rebranding exercise will be undertaken by a suitably qualified organisation, to ensure the newly redeveloped space is carefully marketed and promoted to attract both business and community.

#### **Gateway project**

A small proportion of the budget will be used to fund the development of a gateway art project in a prime location in the town near the car park entrance. A local artist will be appointed to illustrate the history of the town, creating a vibrant gateway to the town centre. This aspect of the project aligns with wider investments which are being undertaken in the town as part of the Tackling Towns programme. It will also complement the Revitalising Rural Town Centre grant. To date, several premises in the town have been successful in their applications to revitalise their shop frontages.

#### **Project Delivery timeline**

The project will begin as soon possible. Project must be completed by end of December 2024 in line with the Shared Prosperity funding period.

The Rural Anchor Team who are responsible for administering both funds will closely monitor progress of the project individual awards. Where a lack of progress is being made, applicants will need to provide clarification as to how they will be able to deliver against the original approved amount. As a last resort this may mean suspension of a project mid delivery.

#### **Physical Assets**

St Clears Town council have entered in a lease agreement with Carmarthenshire County Council as part of an asset transfer programme. The designs for the work have been shared with corporate property who have agreed the proposed works subject to compliance with building regulations.

The project will ensure sustainable practices are adopted when carrying out the works and in the administration of the building.

#### **Ten Towns Programme (Revenue fund)**

#### Purpose:

To consider an application submitted as part of the Ten Towns revenue fund.

#### Background

The aim of the Ten Towns Programme is to increase the resilience and future growth of Carmarthenshire's rural market towns and their surrounding areas.

The Authority has committed £1m capital funding to support the respective towns to take forward some of the capital aspirations identified within their economic growth plans. To complement the capital projects, further revenue funding has been secured from the UK Government's Shared Prosperity Fund as part of the Rural Anchor.

Each town has been given the opportunity to apply for funding of up to £20,000 to be delivered before the end of December 2024.

The application has been assessed by an internal funding panel before being presented to Cabinet member for final decision.

#### **Application for consideration:**

Applicant: Llandelio Town Council Project name: Llandelio Marketing Officer

Grant Requested: £20,000

Llandeilo Town Council, on behalf of the 10 Towns Growth Plan Team, is seeking funding to appoint a Marketing Officer for the town. The role of the officer will include:

- Development of a marketing strategy to promote the town and the surrounding area. The
  officer will work closely with local businesses and community stakeholders to develop a
  cohesive marketing plan to encourage visitors to the area
- Development of marketing and promotional materials to highlight what's on in the town including local events, attractions etc
- Development of new events, working closely with businesses and existing event organisers. This will ensure that the town is able to offer a cohesive calendar of events throughout the year. The officer will also provide support to existing event organisers to help them grow.

The application includes a request to fund the purchase of event infrastructure such as gazebos that can be used for both new events developed as part of the project as well as supporting existing events thus reducing the costs in the longer term.

Llandeilo Town Council is committed to scoping opportunities to sustain the role post funding and will work with CCC's Bureau to identify funding pots.



#### **Project Delivery timeline**

The project will begin as soon as fully approved starting with a recruitment process for this new role. Project must be completed by end of December 2024 in line with the Shared Prosperity funding period.
