Mynydd y Betws Wind Farm Community Benefit Fund Round 14 Applications.

SUMMARY OF PURPOSE OF REPORT

Purpose:

To consider 10 applications submitted as part of the Mynydd y Betws Community Benefit Fund.

Background

Carmarthenshire County Council's Bureau manages the Community Benefit Fund on behalf of ESB (Electricity Supply Board).

ESB has committed to providing a community support fund for the benefit of communities near Mynydd y Betws Wind Farm over a 25-year period. Carmarthenshire receives £86,500 each financial year up until 2038.

Level of Grant Available:

- Tier 1 - £500 - £5,000 – Up to 90% grant
- Tier 2 - £5,001 - £15,000 – Up to 80% grant

Mynydd y Betws Community Benefit Funding provides capital and revenue funding for new and innovative projects which address the following themes:

- Recreation
- Education
- Health
- Environmental
- Energy Efficiency / Sustainability
- Culture

Project Description/ Community Benefit	<p>Betws Community Council has 2 playgrounds, unfortunately, there is no specific disabled friendly play equipment in either of the parks. The Community Council has been contacted by parents of children with disabilities and members of the public requesting suitable play equipment. The new equipment will enable all children to play together in the same playground.</p> <p>Over the last year, a lot of the play equipment at Maesquarre park has come to the end of its life and has been removed. It is essential the equipment is replaced as soon as possible to meet the needs of the local community.</p> <p>The park acts as a focal point for the community and provides a meeting area for grandparents, parents, and children. Lots of parents travel to other areas to use park facilities which have a more varied function. Therefore, better facilities locally will ensure less travel and help reduce the village's carbon footprint.</p> <p>Betws Community Council strongly believe that children with different abilities should be able to play in the same playground. Currently there is limited equipment that can achieve this goal within Betws.</p>

Through recreation, education and by increasing knowledge, confidence and skills a family's resilience would be increased.</p> <p>The activities and support provided would be free of charge which prevents barriers to people accessing the services. The families that attend always face several challenges however these challenges have become more difficult as they have less access to professional support due to the pressures on public services. Many families are still struggling with the aftermath of the pandemic and the cost-of-living crisis and the centre is coming across an increase in mental health issues such as depression and anxiety.</p> <p>The Centre is based in is a former council house in the middle of a large estate of social housing. The Centre has a second site which is a short distance from the main centre, with a</p>

	<p>Community Garden and Ecolodge which provides an indoor room with a kitchen as well as a covered outside area.</p> <p>The Family Centre has a yard measuring 27ft by 39ft, which has been covered in playground tarmac for over 12 years, it is now covered with moss, has plants growing through it and is in a poor state of repair. There is also an dilapidated shed.</p> <p>The grant funding is to remove the tarmac, clear the shed and to provide a new playground surface. The improvements will provide a safe outdoor area for the children and families.</p>
