EXECUTIVE SUMMARY

10 Towns Programme (Revenue fund)

Purpose:

To consider 6 applications submitted as part of the 10 towns revenue fund.

Background

The aim of the 10 Towns Programme is to increase the resilience and future growth of Carmarthenshire's rural market towns and their surrounding areas.

The Authority has committed £1m capital funding to support the respective towns to take forward some of the capital aspirations identified within their economic growth plans. To complement the capital projects, further revenue funding has been secured from the UK Government's Shared Prosperity Fund as part of the Rural Anchor.

Each town has been given the opportunity to apply for funding of up to £20,000 to be delivered before the end of December 2024.

The following applications have been submitted following consultation at a local level. Each application has been assessed and considered by an internal Funding panel before being presented to Cabinet member for final decision. Whilst the funding for the projects will only be secured until December 2024, it is the intention that the jobs created below via the fund will continue post funding through other sources.

Applications for consideration:

Whitland Town Council

Grant Requested: £20,000

Whitland Town Council is seeking funding to recruit a Town Development and Events Co-ordinator for Whitland. Employed by the Town Council, this new role will support the development of several new events and activities in the town to increase footfall and extend dwell time. The officer will be employed for a period of 13 months. The role will complement the town's capital project, which is currently under development, that will provide investment to develop a key asset in the town to facilitate new events as well as develop new town centre-based events to increase footfall. The post will be 100% funded via the grant. Several events have been suggested that could benefit the town following local engagement with town stakeholders such as a seasonal open air Christmas market, St David's celebration as well as open air cinema events at the park located in the centre of the town. The appointed person will also look at sustainable funding streams in order to continue with this support and resource for the town post funding period.

Project Delivery timeline

The project will begin as soon as fully approved starting with a recruitment process for this new role. Project must be fully complete by end of December 2024 to align with Shared Prosperity funding period.

Cwmaman Town Council

Grant Requested: £19,250

Cwmaman Town Council is the lead applicant for the development of the 10 towns project for Cwmaman. Revenue funding is being sought to complement the area's capital Ten Town project which includes the redevelopment of the bunkhouse facility and narrative trails which aim to enhance and develop the area's tourism appeal. The project will be 100% funded via the grant.

The grant request is for £19,250 for the development of immersive audio trails that will highlight the area's natural and cultural heritage. The audio trails will guide visitors through the community's historical landmarks, unveiling captivating stories from the past. The addition of audio trails will enhance the visitor experience by using engaging narratives and educational content to transport visitors to pivotal moments in history. This is intended to cultivate a deeper appreciation of local heritage and attract both local and national tourists. In addition, funding is being sought to support the development and sustainability of the bunkhouse as an attractive accommodation space in the area. Funding is being sought for the development and implementation of a strategic marketing plan which will include both off and online promotion, engaging content creation as well as local and national promotion.

Project Delivery timeline

The project will begin as soon as fully approved to ensure timely completion of audio trails by the start of next year's visitor season. Project must be fully complete by end of December 2024 to align with Shared Prosperity funding period.

Kidwelly Town Council

Grant Requested £10,000

Kidwelly Town Council is the lead applicant for the development of the 10 Towns Project in the town. The need to create better active travel links between the town and the nearby Park Dean resort and Ferryside has been identified as an opportunity within the economic growth plan for the town.

Working in partnership with Carmarthenshire County Council's Active travel team, Kidwelly Town Council is seeking funding to undertake an engagement exercise designed to gather essential insights and scoping to develop new active travel routes which will inform future applications for capital support. The engagement exercise will take place during summer 2024 and be completed by early Autumn. Kidwelly Town Council will be supported by, and work in partnership with, relevant Carmarthenshire County Council departments on this project as any future capital projects stemming from this work will be led by the Authority.

Project Delivery timeline

The engagement exercise will take place during summer 2024 and be completed by early Autumn 2024.

Llandovery Town Council

Grant Requested: £19,970

The growth plan team for Llandovery has identified and prioritised projects that support and further develop the town's visitor economy through the development of a suite of tourism focussed projects. Currently in development as part of their capital project is the installation of outdoor canopies and extended seating in the Market Square area of the town. This picturesque area in the town is surrounded by retailers and eateries and will be developed to create an informal dining and event space which proved successful when utilised during the Eisteddfod week in May 2023. To further add value to their capital project, Llandovery Town Council on behalf of the growth plan team is seeking funding to re-instate a local produce market in the town, operating on the 3rd Saturday of every month from Market Square.

Focussing on local produce primarily within a 25-mile radius, a market co-ordinator will be employed on a self-employed basis to co-ordinate and facilitate the market to ensure it is widely supported. Local musicians and artists will be invited to provide entertainment at market days creating a vibrant atmosphere in the town.

Project Delivery timeline

The project will begin as soon as fully approved starting with a recruitment process for this new role. Project must be fully complete by end of December 2024 to align with Shared Prosperity funding period.

Llanybydder Old School Trust

Grant Requested: £20,000

The lack of economic and social space in Llanybydder was highlighted in the town’s economic growth plan which led the growth plan team to prioritise the re-development of the Old School as their capital project. The vision for this project is to create a wellbeing hub, offering space for self-employed practitioners to practice, providing both economic opportunity and access to new services for the community. A shared working space and community café area will also be developed as the building is regenerated.

In order to ensure the success of the centre, the Old School Trust is seeking funding for the creation of a Town Development Officer. Employed by the Trust, the primary role will be to support the re-development of the centre by developing a pricing and marketing strategy, liaising with support service facilitators such Hwb Fach y Wlad, Business Wales, Repair café Wales to develop an activity calendar as well as developing the shared workspace. The officer will also be available to support the existing Town market co-ordinator to explore opportunities to further enhance and develop the weekly local market in the town. This co-ordinated approach will provide far reaching benefit to the town by increasing its visitor economy, creating new opportunities for local businesses as well as developing new services for the community.

Project Delivery timeline

The project will begin as soon as fully approved starting with a recruitment process for this new role. Project must be fully complete by end of December 2024 to align with Shared Prosperity funding period.

St Clears Town Council

Grant Requested: £20,000

St Clears Town Council has taken over the management of Y Gat (formerly West Wales Craft Centre) in the town following an asset transfer from the Authority. Highlighted as an anchor building for the town, the re-development of the building is the focus of the town’s capital project application. To support the new administration of the building, a branding exercise is required to develop a new identity for the building highlighting the facilities and provision that will be made available from the premises. To further promote these new activities as well as addressing the lack of online presence for the town, a new fit for purpose website will be

developed as a marketing tool for the area. The content will be developed to showcase local businesses and attractions as well as activities and opportunities at Y Gat.

The installation of town centre digital screens will provide an opportunity for the website content to be viewed in the town providing real time information of attractions and local businesses. The Town Council is currently in the process of recruiting a co-ordinator for Y Gat which is being funded from their own resources. The updating and marketing of the website and screens will form part of their duties.

As part of the community consultation exercise undertaken, the creation of a local produce/craft market was identified as a key priority from local businesses and the local community. This would be an opportunity to increase the weekend visitor economy in the town which has been noted as being lower than that of weekdays. The funding request is for a market co-ordinator to facilitate, promote and develop the new offer for St Clears with a view of becoming sustainable post funding period.

During the community consultation exercise, the need for youth provision in the town was a clear priority for the community. St Clears Town Council has already established a youth provision programme over the summer months with over 20 youths attending sessions. As the colder season approaches, there is a need to secure a space to continue the service. The Leisure Centre in St Clears has been identified as a suitable space to support the provision over the winter months. Accompanying the request for support with accommodation costs, is a small financial request for support with a town-based community art project led by the youth club to design vibrant and colourful art on the utility boxes in the town. This project will complement the wider town regeneration projects that are under development as part of funds secured from Shared Prosperity fund Tackling Towns Project.

Project Delivery timeline

The project will begin as soon as fully approved starting with a recruitment process for this new role. Project must be fully complete by end of December 2024 to align with Shared Prosperity funding period.

The option of not approving these projects in whole or part is open to Cabinet member. However non approval will put at risk the Council's ability of delivering the Rural anchor programme within the UK Government's programme timeframe.

Policy, Crime and Disorder

The 10 towns programme provides an opportunity for rural market towns to create new economic benefit and opportunities developed as a recommendation from the Moving Rural Carmarthenshire Forward Plan.

The above is aligned with the county's existing strategies and plans including the Local Investment Plan for Carmarthenshire, Economic Recovery Plan, Local Innovation Strategy, Wellbeing Assessment, and the South-West Wales Regional Economic Delivery Plan and Corporate Strategy.

The Programme will support the objectives of the Wellbeing & Future Generations Act by targeting interventions which aim to ensure that the Welsh speaking communities of the County remain vibrant and sustainable communities.

Legal

Terms and Conditions will be issued to each applicant which have been verified by CCC legal department.

Finance

This fund is made available as part of the 10 towns programme with funding secured from the UK Government Shared Prosperity Fund as part of the Rural Anchor. A budget of £200,000 is available for the delivery of this fund which equates to £20,000 per town.

Risk Management Issues

A programme level risk management process will be followed to ensure that risk is assessed and managed at all levels.

A key risk is the short delivery timeframe of SPF with all 3rd party grants required to be financially completed by the end of December 2024.

At a project level, a risk register will be maintained together with appropriate mitigation measures. The Rural Anchor Team who are responsible for administering both funds will closely monitor progress of the project individual awards. Where a lack of progress is being made, applicants will need to provide clarification as to how they will be able to deliver against

the original approved amount. As a last resort this may mean suspension of a project mid delivery.
