#### LLANELLI SHOPMOBILITY

The County Council has supported the Llanelli Shopmobility scheme since 2011. The current funding arrangement is due to expire this year.

The Llanelli scheme provides a valuable service for the disabled and has been relatively successful.

The group generates income from charges and fund raising. The scheme is however mainly reliant on the County Council's financial support. The Group has requested further financial support from the Council for the current year, amounting to £14,650.

Shopmobility is one of many initiatives being encouraged by the Authority to support the town. It fits with the Authority's Parking Strategy priorities

The Council has set aside funding to fund a further twelve months support. The Council has set aside funding to fund a further twelve months support.

It is therefore recommended that the Llanelli Shopmobilty scheme be supported with a grant of £14.650 for a further twelve months.
