Advice is being sought to confirm future management options for the hostel accommodation specifically, and the wider site as a whole.						
A Joint Management Agreement (JMA) with Pendine Community Council (PCC) has been modelled to explore the possibility of managing the wider site on an integrated basis.						
A JMA venture is an enterprise under-taken by two organizations to share the expense and profit of a particular business project. The proposed Pendine JMA would not be a business organisation in the sense of proprietorships, partnerships or corporation but an agreement between PCC & CCC for the particular purpose of regenerating Pendine, through the Pendine Attractor project.						
Existing bylaws and agreements are being reviewed to ensure clarity for any future joint working.

A full risk register is being kept for the project and is updated monthly. The new buildings will be incorporated into the corporate portfolio of CCC and insured accordingly.

6. Staffing

Likely to be a need to recruit some additional site management staff, but detail subject to future operating model. All costs integrated into revenue business case modelling.
