Arrangements have been put in place to continue aspects of youth work support for 16-25 NEET cases through to March 2022. 	<p>At the timely request of the Scrutiny and Children Committee</p>

	<ul style="list-style-type: none"> • European Social Fund Cynnydd (11-16) operational delivery ends July 2022. The Youth Support service is currently formulating an options appraisal to inform exit strategy for DMT. • Funding post ESF- there is no certainty currently regarding the UK Government response to ongoing funding of work to replace the gap left by ESF ending. • Families First Funding for post 16 youth work support (including NEET related work) has been reduced by 50% and is supplemented by Housing Support Grant Funding. 2021/22 is a transition year regarding Families First and Housing Support Grant funding for this project and there is wider work being led by Housing and Children's Services in relation to 16-25 Housing which may well influence NEET delivery post April 2022. • Families First funded School and College Based Youth Work has been subject to reductions and/or standstill budget in the last 6 years. This has caused the staffing resource to reduce its size and capacity. This project is undergoing a review led by Janine Patrick in conjunction with YSS key managers.
