CODE OF CONDUCT TRAINING

In accordance with arrangements previously approved by the Standards Committee code of conduct training sessions were held for Town and Community councillors on the 21st and 22nd July via Zoom.

Attendance was slightly down on previous years, being as follows

21st July – 30
22nd July – 50

A total of 23 councils (roughly a third of the total number) were represented.

Copies of the training presentation, a briefing note on recent code of conduct cases and a feedback questionnaire have been sent to all Town and Community Councils.

NB. Carmarthen Town Council also arranged its own code training events with One Voice Wales on the 20th and 21st July which were attended by 9 of its councillors plus the clerk and deputy clerk.
