- Lluniwyd yr argymhellion yn yr adroddiad gan y Grŵp ar ôl ystyried ystod o dystiolaeth dros gyfres o gyfarfodydd a gynhaliwyd rhwng mis Mai 2018 a mis Chwefror 2019.
- Cyflwynwyd yr adroddiad a'r argymhellion i Aelodau'r Cabinet ar y 7fed o Hydref, 2019, ond roedd angen mwy o fanylion ar yr Aelodau o ran goblygiadau e.e. cyllid, polisi.
- Roedd diweddariad yn barod i'w gyflwyno ym mis Mawrth 2020 ond roedd Covid-19 yn cael blaenoriaeth ac roedd swyddogion yn canolbwyntio ar faterion eraill.
- Yn ystod Mis Ionawr/Chwefror 2021 diweddarwyd yr adroddiad ymhellach yn barod i'w gyflwyno/trafod
- Ar 19 Ebrill 2021 cyflwynwyd diweddariad i'w ystyried. Cam gweithredu o'r cyfarfod hwnnw oedd datblygu papur ar wahân i gynnwys rhagor o wybodaeth mewn perthynas â adolygu trefniadau derbyniadau i ysgolion.

EXECUTIVE SUMMARY

EDUCATION AND CHILDREN'S SERVICES SCRUTINY COMMITTEE TASK & FINISH GROUP REPORT 2018/19- A REVIEW OF THE CURRENT PROVISION FOR EARLY YEARS EDUCATION, CHILDCARE AND PLAY OPPORTUNITIES.

The Education and Children Scrutiny Committee has a key role to play in monitoring services, development of key policies and strategies, as well as identifying areas for improvement or development within their remit.

As part of their investigative role, Scrutiny Committees can establish a Task & Finish Group during each municipal year. This is a sub-group of the main committee and asked to investigate specific issues and report back findings and recommendations for approval before presenting them to the Executive Board.

The Education and Children Scrutiny Committee agreed in principle to undertake a review into the current provision for early years education, childcare and play, including the following items:-

- Admissions Policy for Schools
- Foundation Phase Provision for 3 year olds
- Standard of provision
- Play
- Childcare
- The new 30 hour Childcare Offer

As a result of the review, a Draft Report was presented to the Scrutiny Committee on the 24th April 2019.

An initial response by officers to the recommendations was presented to Cabinet on the 7th of October 2019. However, Cabinet Members asked officers to provide more detail on the implications of implementing the recommendations e.g. funding, policy. An update was ready for presentation in March 2020 however responding to Covid-19 took priority and officers were focused on other issues.

During January/February 2021 the report was further updated ready for presentation/discussion

On the 19th April 2021 an update was provided for Members to consider. An action from that meeting was to develop a separate paper to include further information in relation to our Admission Policy. This is attached.

In addition officers have been charged to consider the implications of the Senedd Co-operation Agreement between Labour and Plaid Cymru and any possible impact on the recommendations contained in the report.

1. Policy, Crime & Disorder and Equalities

If the recommendations are supported by the Cabinet there will be changes to Carmarthenshire's related policies which will need to be consulted upon and discussed e.g. Admissions Policy, start of school age. We will also need to consider the impact of the Senedd Co-operation Agreement between Labour and Plaid Cymru.

2. Legal

We are obliged to abide by legislation in respect to many service areas affected by these proposals e.g. School Admissions, 30 Hours Education and Childcare. We will need to consult on changes in line with legislation and follow the appropriate corporate processes.

3. Finance

Implementing the recommendations will require dedicated officer time from a range of service and departments. Implementing some recommendations could result in additional costs.

4. Risk Management Issues

We need to consider the implications of these recommendations on our service delivery and those provided by partners e.g. one identified risk related to developing nursery provision on every school site which could have an adverse impact on some non-maintained providers of education.

5. Staffing Implications

Implementing these recommendations will require input from officers. Many of the recommendations would require substantial additional input e.g. *The Council undertake a formal review of its current admissions policy for full time education for 4 year olds (the rising 4s policy). Financial and service impact modelling should be undertaken to inform any change to the policy, which should be along similar lines to other authorities within the ERW consortium.*

6. Physical Assets

Implementing some of these recommendations could require extending school building to provide additional space for an increased number of pupils or investment in upgrading/remodelling buildings.
