| Extension Of Public Space Protection Order (Carmarthenshire Dog Orders) | <p>In 2016, the Council made the Carmarthenshire County Council (Dog Control) Public Spaces Protection Order, which came into force on the 1st July 2016 for 3 years. In 2019 the Order was extended for a further period of 3 years with effect from the 1st July 2019. It is therefore due to expire in 2022.</p> <p>As part of the review, approval was given by Cabinet Member Decision for Public Protection on the 2nd September, 2021 that the authority sought the views of a number of consultees on the extension of the 2016 Order.
