# EXECUTIVE SUMMARY CABINET MEMBER DECISIONS MEETING FOR SOCIAL CARE AND HEALTH 18 MARCH 2022

# SUBJECT: LOCAL AUTHORITY RESIDENTIAL CARE STANDARD CHARGE FOR 2022-2023

There are currently 7 homes with a total of 248 beds in Carmarthenshire County Council's own residential homes. The overall budgeted costs for running the Authority's residential homes together with the number of beds available and the occupancy levels are the determining factors in calculating the annual Standard Charge.

In previous years, the calculation for the Standard Charge was actioned later in the year to wait for confirmation of the pay award, but its more prudent to agree the rates earlier, so that individuals effected are aware of the increase as early as possible.

For 2022-23 there has been no change in the number of Local Authority beds. Staffing costs have increased due to a revaluation of care staff from C to D grade. An estimated increase in staff costs of 3.25% in line with the Council's Revenue Budget Strategy and extra costs pressures on supplies and services of approx. 2-3%. There are no proposed savings efficiencies reducing the budgets, but there has been a rebalancing of costs between the Dementia Beds and Standard Residential which reflects the growing dependency levels in Residential Care and the difference in uplifts between the 2 charges.

As a result, the charge for mainstream beds will increase by 9.86% and Dementia beds by 5.82%.

### Recommendation

The Standard Charge for Local Authority Older People residential care homes be increased from £654.06 to £718.56 for Mainstream beds and from £884.17 to £935.60 for Dementia beds.
