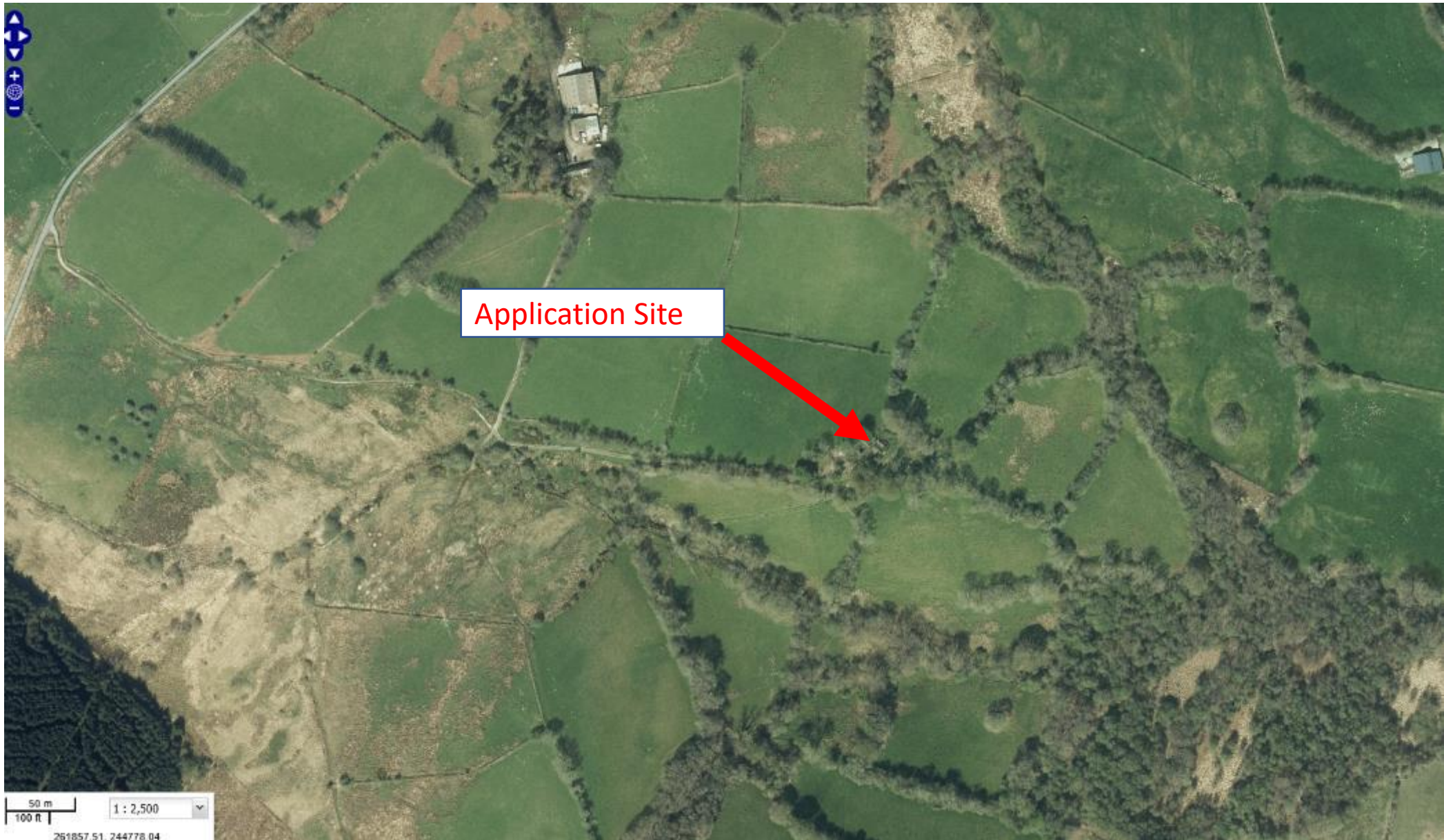








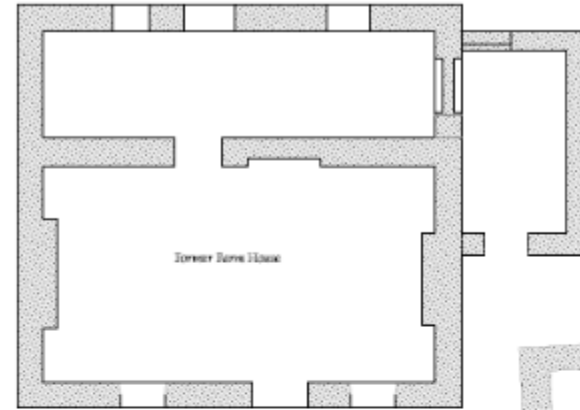












Floor Plan 1/20

























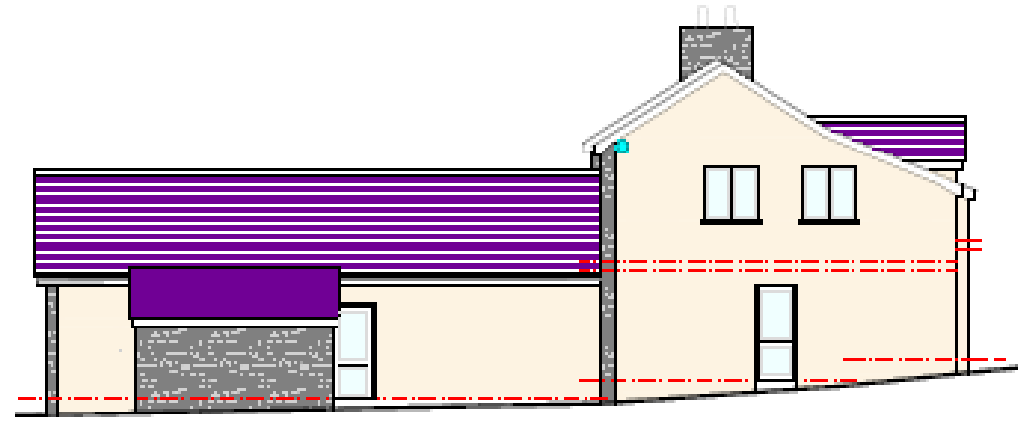








Front Elevation 1:100



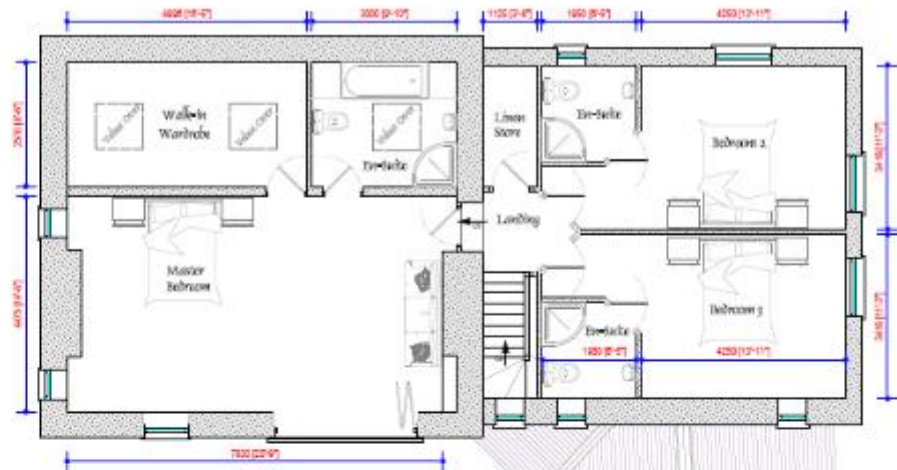
Side Elevation 1:100

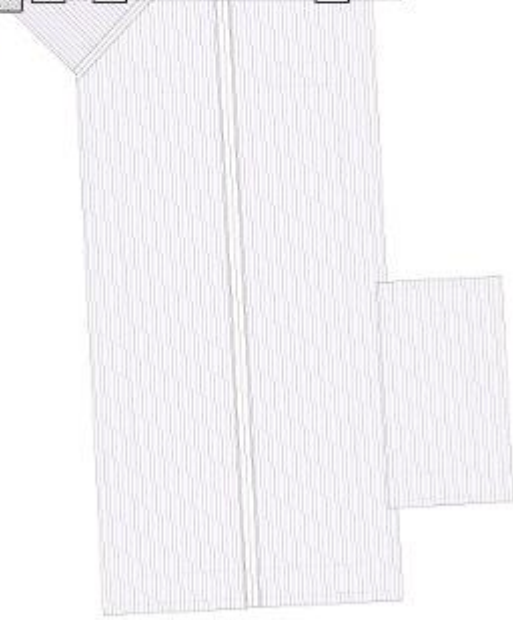

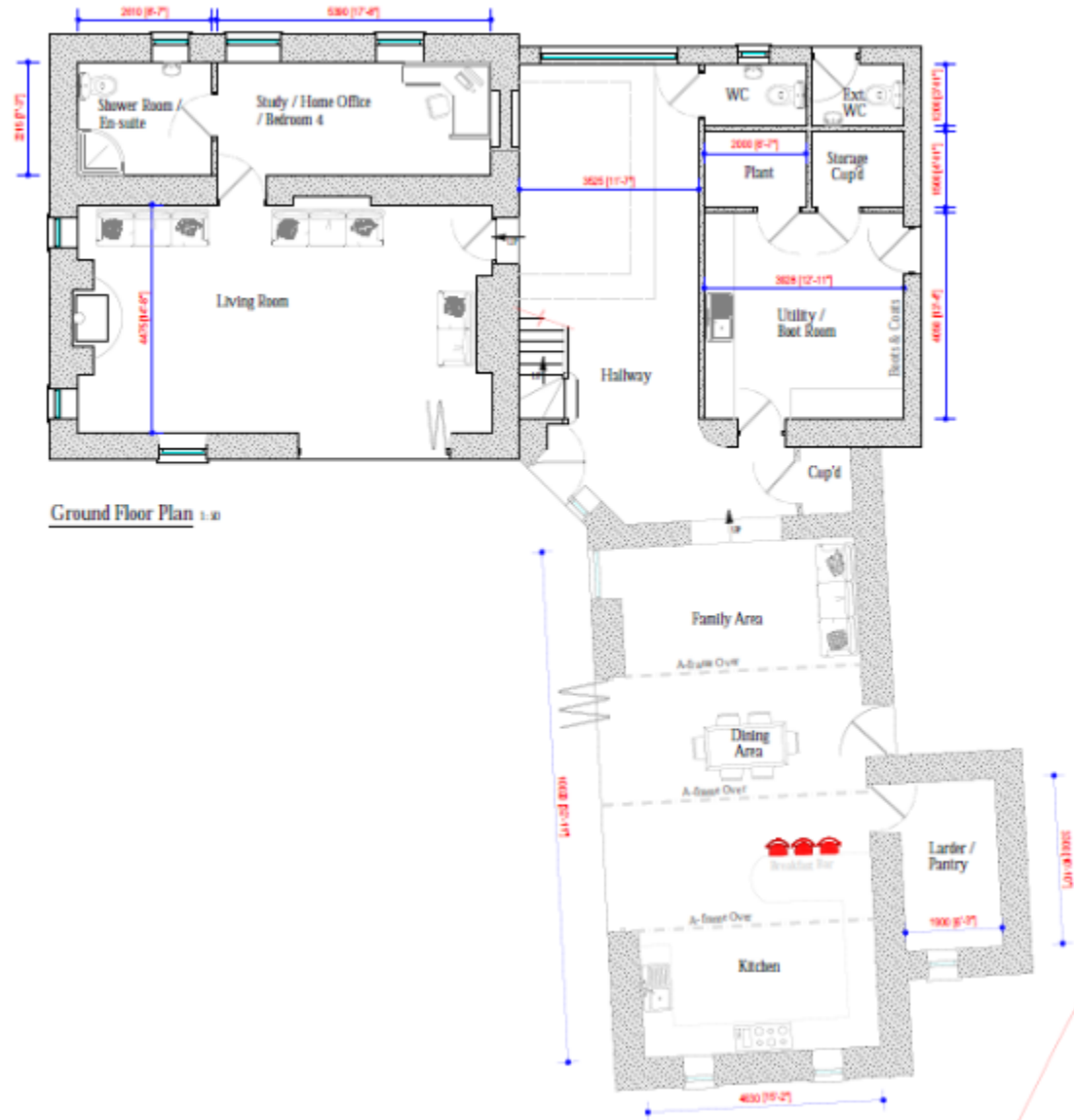


First Floor Plan 1:20



Roof Plan 1:100

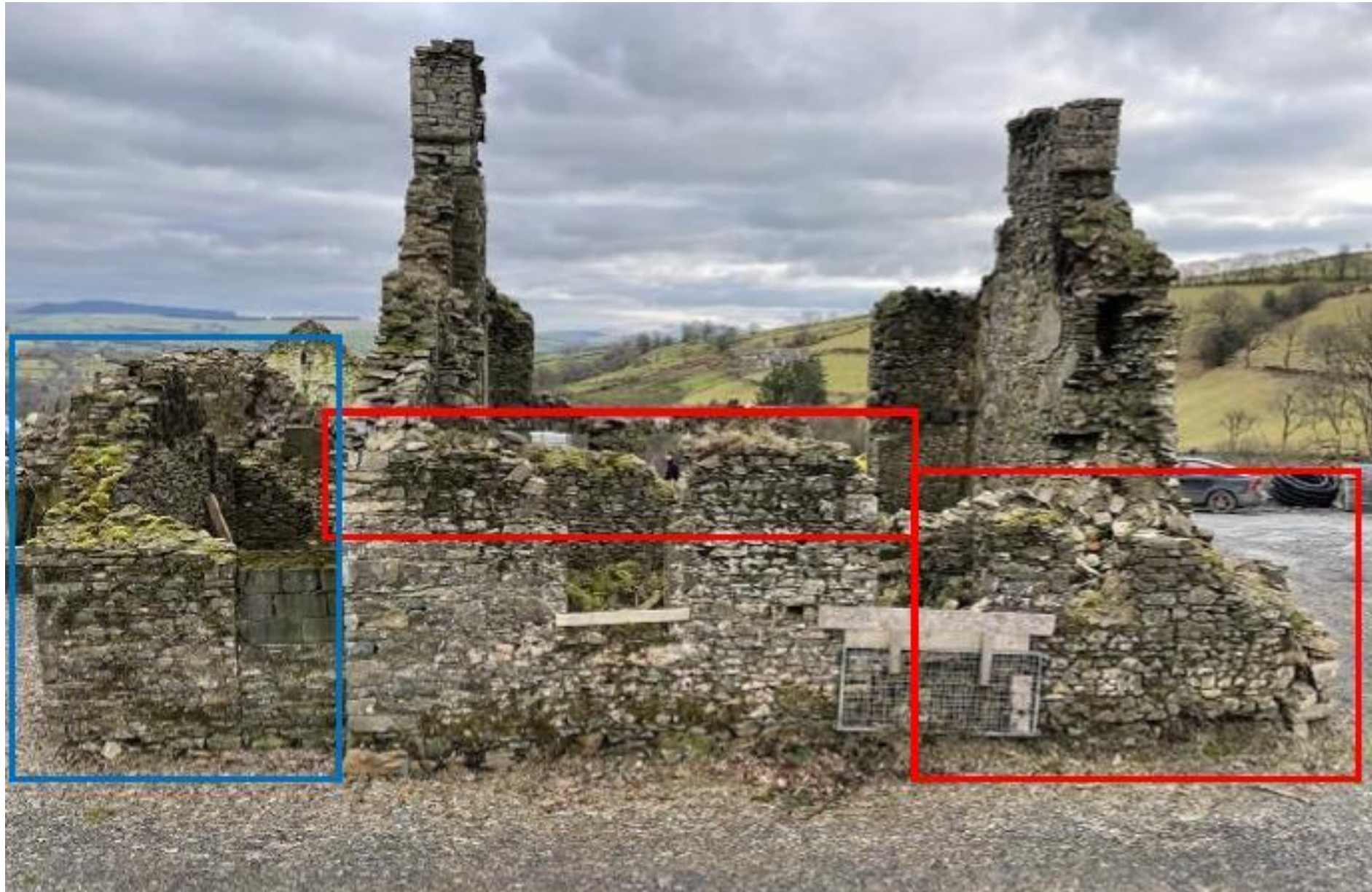


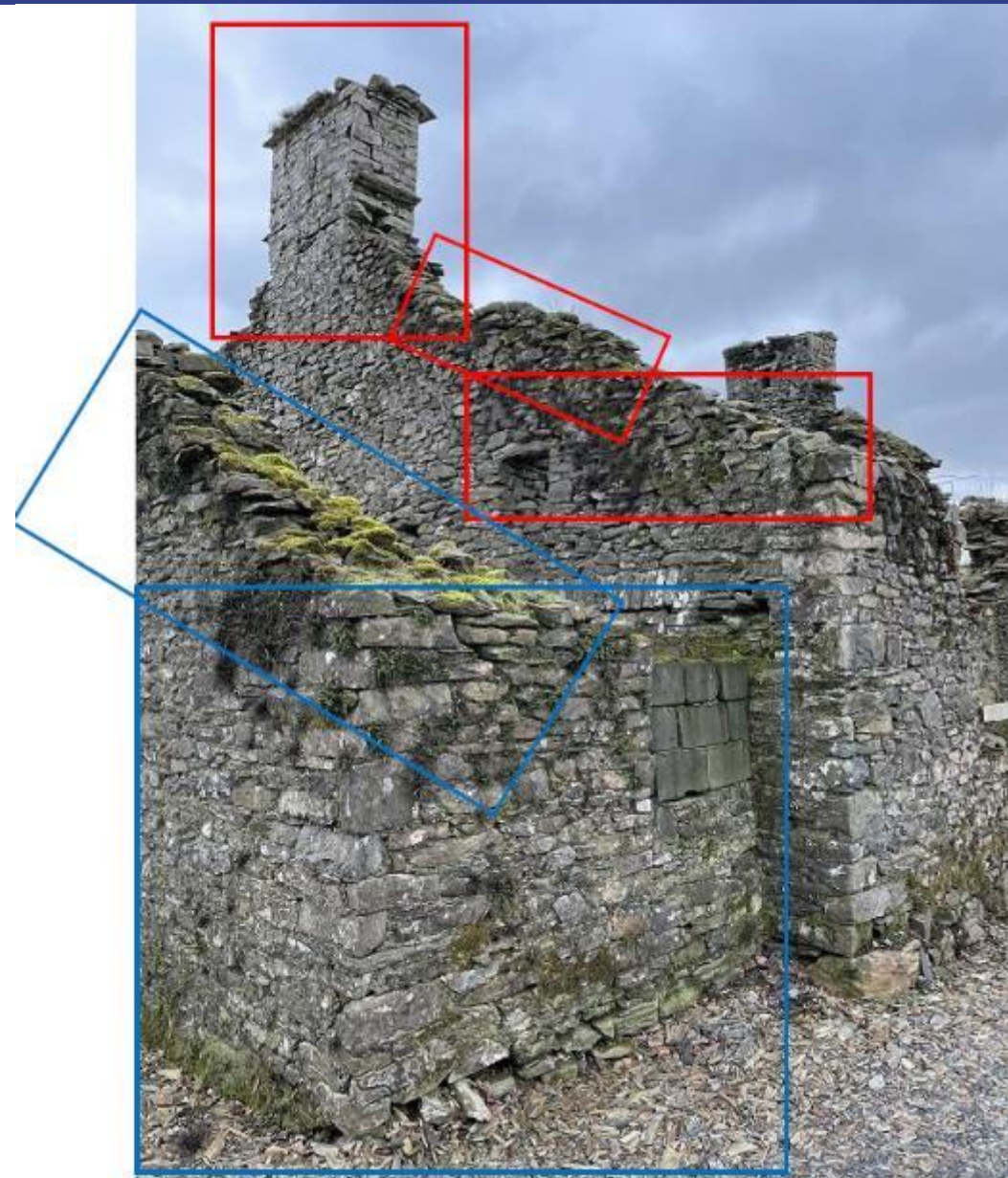


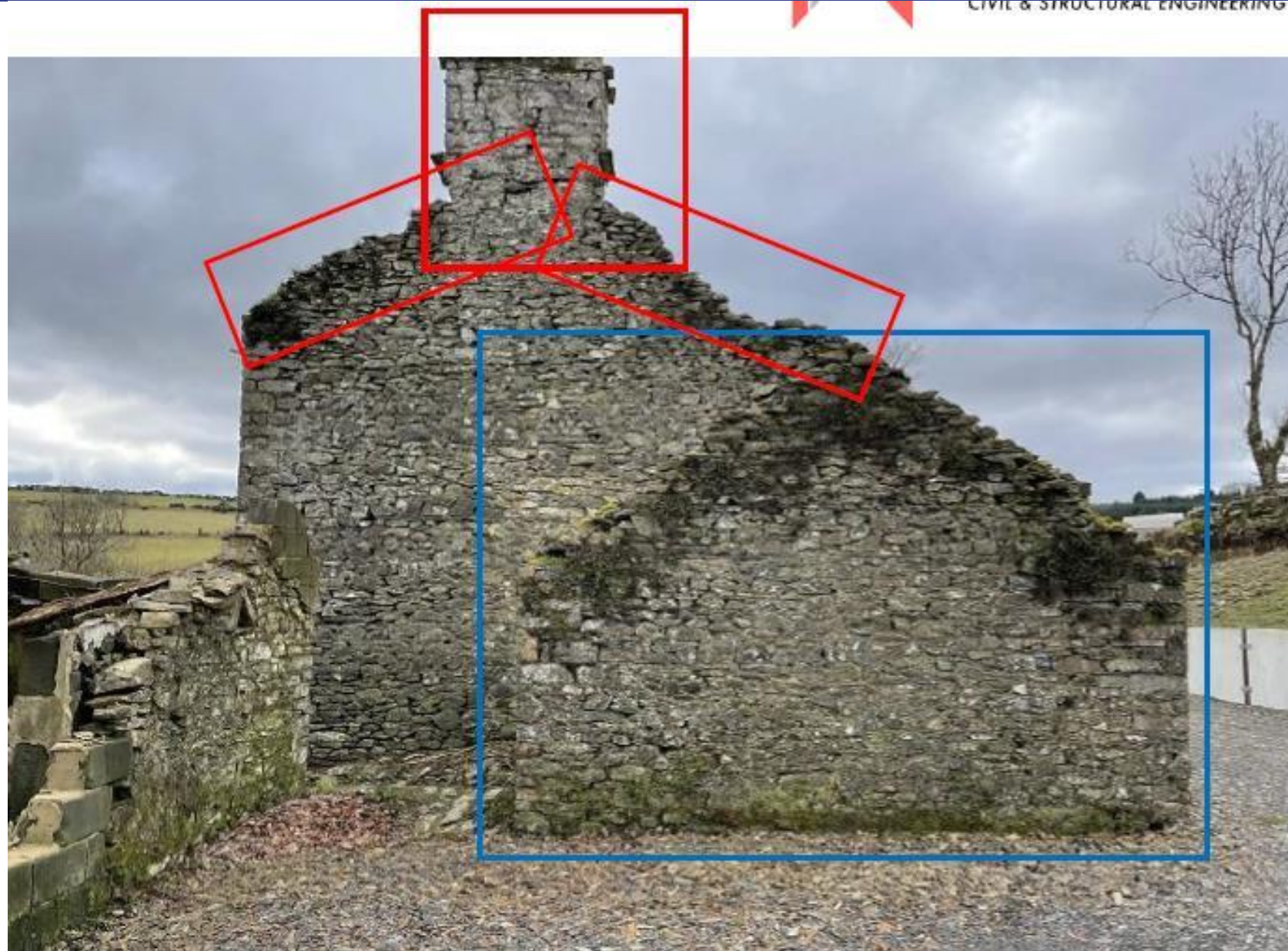
Ground Floor Plan 1:50

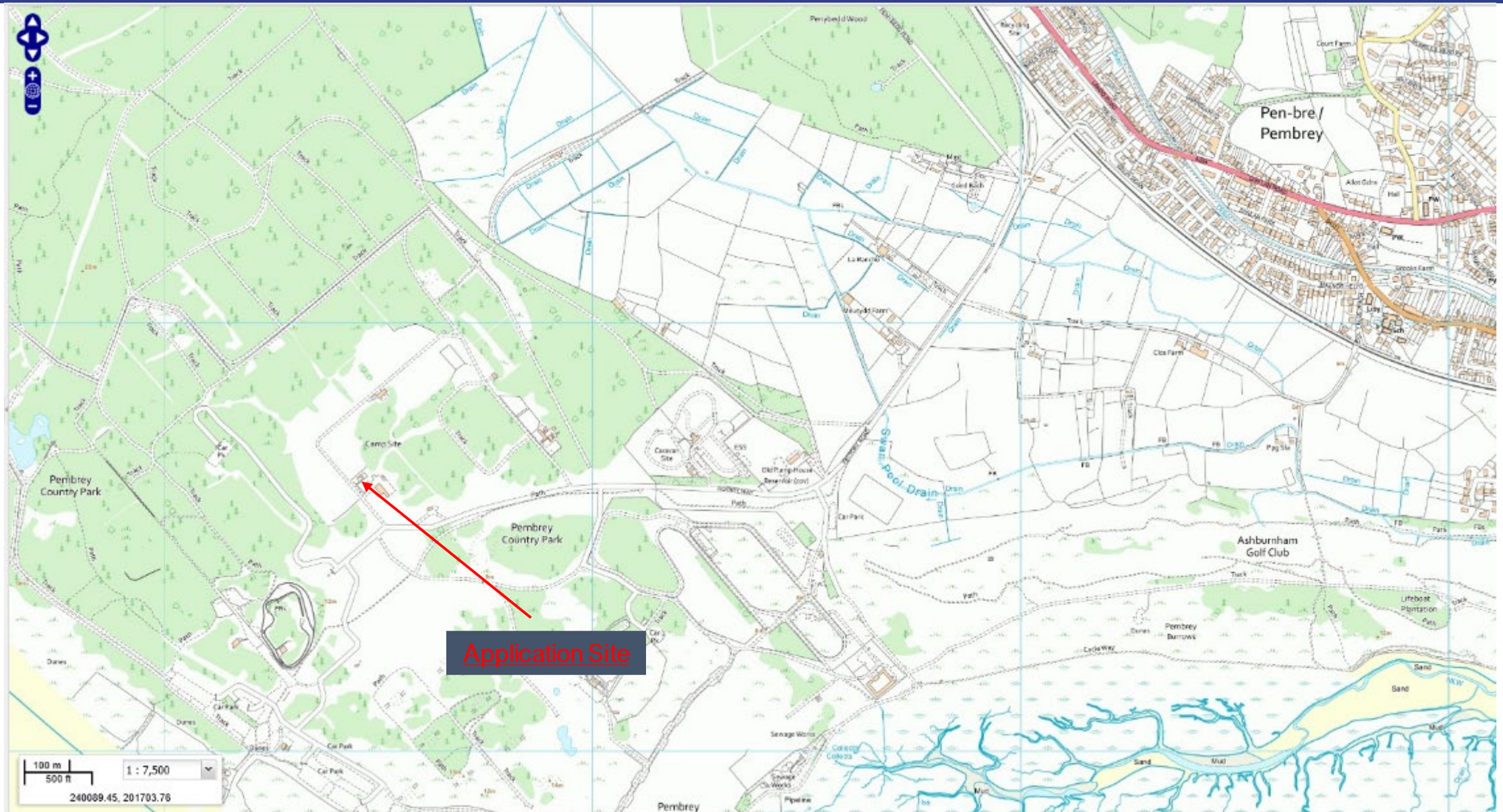

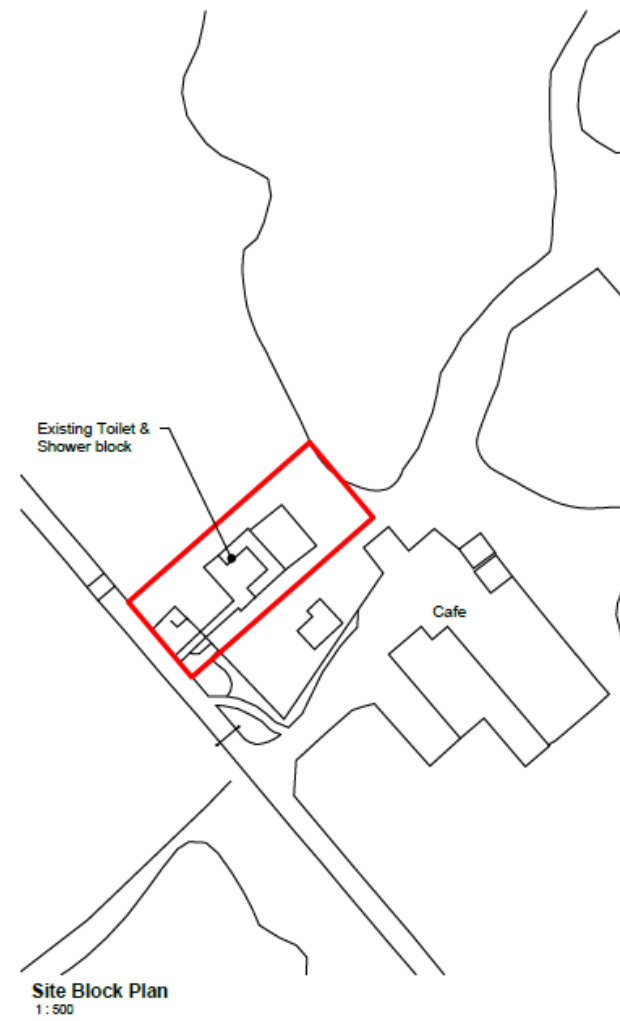
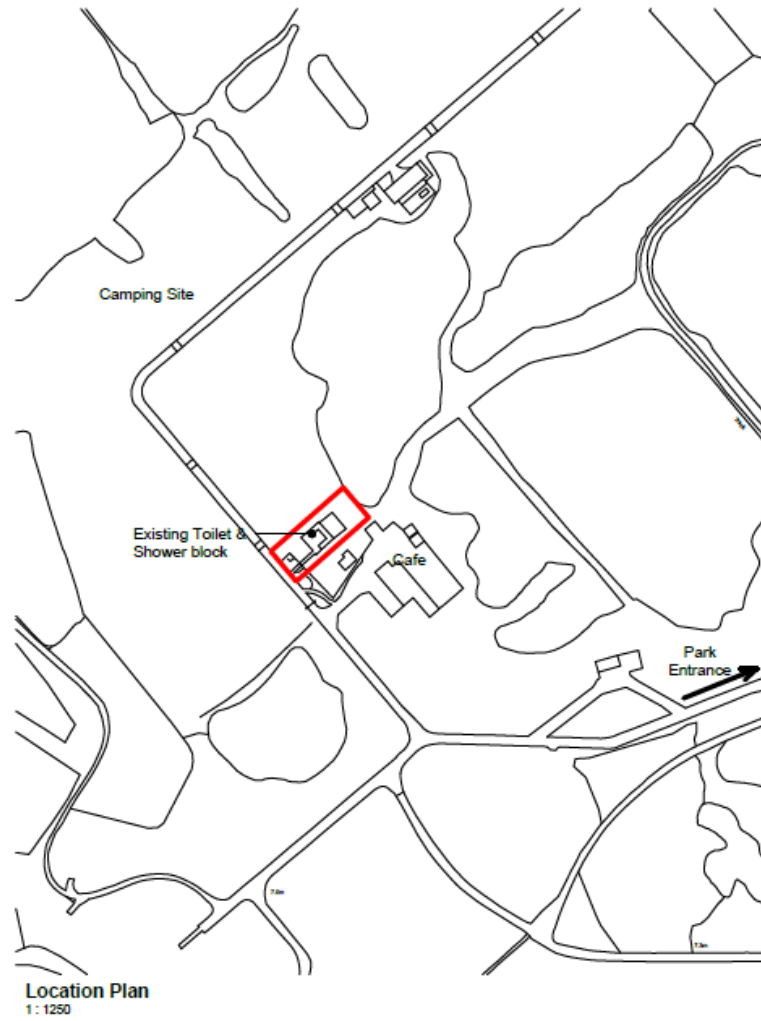
