**CARMARTHEN SHOPMOBILITY**

The County Council has supported the Carmarthen Shopmobility scheme since 2011. The current funding is an annual arrangement renewed each September.

The Carmarthen scheme provides a valuable service for those with mobility impairments to access the town and is important in helping the town's post-covid regeneration.

The scheme is mainly reliant on the County Council's financial support and an annual grant is normally provided which is funded from the County Council's Community Transport element of the Bus Services Support Grant.

In recognition of increased operational pressures it is proposed that the grant is increased by just over 5% for the period making the annual grant payable in 2023/24 a total of £16,000.

Shopmobility supports the County Council's updated *Corporate Strategy 2022-2027* and our Well-Being objectives of:

- Enabling our residents to live and age well.
- Enabling our communities and environment to be healthy, safe and prosperous

The Council has set aside funding to support Shopmobility in Llanelli and Carmarthen for a further twelve months.

Should there be any surplus funding at the end of their financial year it would be relatively modest and reinvested in supporting the improvement of the service.

**Recommendation:**

It is recommended that a grant be provided to support Shopmobility in Carmarthen from September 2023 to September 2024 of £16,000.
