EXECUTIVE SUMMARY Cabinet 18th September 2023

DEVELOPMENT FUND APPLICATION

The report provides a brief update on the Development Fund and identifies that the Authority has £604k of funds available for new projects.

This sum will rise to \pounds 1.64m in 2024/25 and \pounds 1.68m in 2025/26 when future repayments to the fund are made. These values are dependent on the sale of the Grillo site in 2024/25 to reimburse the Development Fund.

This report seeks approval for the sum of £175,000 to fund the electrification of additional pitches, generating increased income. It is proposed that the repayment for the above scheme be over four years.
