## EXECUTIVE SUMMARY

#### SHARED PROSPERITY FUND BUSINESS RENEWABLE ENERGY FUND – LIKEAFISH SWIM SCHOOL LTD

##### 1. Background

Likeafish Swim School Ltd is a swimming school based at Pensarn, Carmarthen who provide swimming lessons and other aquatic activities.

The proposed project involves the installation of a 60kw solar panel system with a 10kw battery storage support.

It is expected that the project will reduce the businesses demand on the grid by as much as 60-70% and produce an annual output of around 48,000kWh

It is estimated that 30.57552 tonnes of carbon will be saved over the course of 3 years.

##### Recommendation:

To approve a grant award of £25,000 towards an eligible project cost of £56,656.42 for the installation of 60k/w solar panel system and a 10kw battery storage support, subject to:

- Legal charge placed on lease,
- Landowner consent query being resolved.

The funding will come from the Shared Prosperity Fund – Business Renewable Energy Fund.

### 2. Legal

The Shared Prosperity Fund Business Renewable Energy Fund constitutes a subsidy and is governed by subsidy control rules. The proposed grant award is a subsidy by way of Minimal Financial Assistance (MFA). The grant recipient has confirmed that they have not received any other subsidy that would result in this award exceeding the MFA limit of £315,000 in this and two previous financial years.

As a condition of grant Legal charges will need to be registered on the lease for the building that is supported under the scheme.

The terms and conditions and grants agreement for the Shared Prosperity Fund Business Renewable Energy fund have been approved by legal.
