To consider an application from Parkdean Caravan Parks Limited, to Vary a premises licence to:-

Update the Premises Name to "Pendine Sands Holiday Park"; approve alterations to the layout plans to include the outdoor areas as marked on the plans provided with this application.

Add Indoor Sporting Events, Boxing and Wrestling, Provision of anything similar to live and recorded music, or performance of dance – all indoors Sunday to Thursday 1000 to Midnight, Friday and Saturday 1000 to 0100 the following morning.

Add Late Night Refreshment indoors Sunday to Thursday 2300 to Midnight, Friday and Saturday 2300 to 0100 the following morning;

All of the above licensable activities and opening hours to be extended from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day.

Extend Plays, Films, Live Music, Recorded Music and Performance of Dance outdoors Monday to Sunday 1200 to 2300.

To remove the following outdated conditions to be replaced with more appropriate up to date conditions as listed in Section 16 in the application form:

Annex 2 under Prevention of Crime and Disorder remove the following conditions:-  
4, 6, 7, 11 to 16.

Annex 2 under Public Safety remove the following conditions:- 1, 2 – 17, 19.

Annex 2 under Protection of Children from Harm remove the following conditions:-  
1, 2, 4 and 5.

All other licensable activities, hours, conditions and layout plans to remain as existing.

The Licensing Authority have made representations, which are attached as Appendix **C**.
