EDUCATION, YOUNG PEOPLE AND THE WELSH LANGUAGE SCRUTINY COMMITTEE FORWARD WORK PLAN FOR 2024/25

The draft Forward Work Plan for 2024/25 has been developed under the direction of the Education, Young People and Welsh Language Scrutiny Committee during its Forward Work Planning session held on 10 April 2024. The Forward Work Plan is a flexible document which can be updated throughout the year as new information emerges, and therefore additional informal planning sessions may be convened throughout the year, as and when required.
