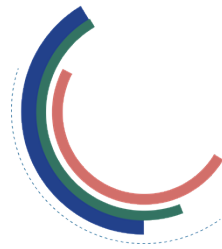

BRIEF SUMMARY OF PURPOSE OF REPORT

The report reflects the level of support currently offered by Partneriaeth across the business plan in operation since September 2024. Partneriaeth is currently offering a good range of support in line with expectations from LA partners.

Partneriaeth is offering an appropriate range of support for its schools and local authorities. This is evidenced in a range of stakeholder groups as well as strong collaborative working with LA colleagues. Officers are providing suitable bespoke support for schools and clusters and this, once again, has been delivered in collaboration with LA officers.

The business plan is monitored quarterly and Partneriaeth is on track to deliver on expectations in the Business Plan. Resources and performance are discussed regularly with Directors of Education in the Strategic Group.

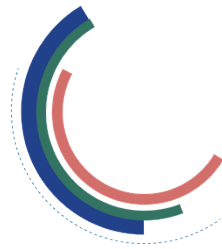
