**EXECUTIVE SUMMARY

FORWARD WORK PROGRAMME

The committee adopted a formal work programme for the 2024-2025 municipal year, to help plan its workload over the year.

There is a need for the committee to undertake a similar exercise for the 2025-2026 municipal year.

A draft programme is attached for consideration.

Two changes are suggested compared to the previous programme

1. That the statutory meeting between the full committee and the political group leaders of the Council take place at the May 2025 meeting and,
2. That the committee receive an annual report regarding code of conduct complaints notified to the Monitoring Officer during the preceding year which have not resulted in any referral to the APW or Standards Committee. As these are complaints which the Ombudsman does not consider require any further action, it is suggested that the report be anonymised and simply indicate
 - (a) The part of the code to which each complaint related
 - (b) The nature of the complaint
 - (c) The Ombudsman's decision in relation to that complaint
 - (d) The reasons for that complaint.

This will help the committee to identify any relevant trends. It is proposed that the report be considered at the last meeting in each municipal year, so its contents can help inform the following municipal years code of conduct training.
